Defence

- 1. Defence Research and Development Organisation (DRDO) successfully test fired anti-tank 'Nag' missile in Rajasthan.
- Anti-tank Nag missile is one of the 5 missile systems developed by DRDO under integrated guided missile development programme (IGMDP). 4 other missiles under this programme are Agni, Akash, Trishul and Prithvi.
- Nag missile is a third generation anti-tank guided missile which works on "fire and forget" principle.
- 2. India successfully test-fired indigenous first all weather tracked-chassis Quick Reaction Surface-to-Air Missile (QR SAM). QRSAM has been jointly developed by Defence Research Development Organisation (DRDO) and Bharat Electronics Limited. It has range of 30 KMs.
- 3. Indian Army received its first batch of bullet-proof helmets, manufactured by Kanpur-based MKU Industries at cost of INR 180 crores. These bullet proof helmets are capable of withstanding the impact of 9mm ammunition fired from a short range.
- 4. Indian Army will possibly do away with colonial-era Sahayak System and considers recruiting civilian staff in peace stations, in wake of rising cases of jawans coming out against Sahayak system as Some jawans have been treated as servants by their attached officers.
- Sahayak system is when a soldier is attached to officers to help them carry out their responsibilities, including protecting officers, maintaining their weapons and equipment etc. Approx 50,000 sahayaks serve in Army where Air Force and Navy do not have sahayak system.

- 11. Second Scorpene-class submarine *INS Khanderi* is ready for surface sea trials, built by Mazagon Dock Limited (Mumbai). It is 2nd of 6 submarines being built at MDL in collaboration with France's DCNS as part of Project 75 of Indian Navy. First was INS Kalvari.
- 12. USA Approved sale of state-of-the-art Guardian 22 unmanned Guardian drones to India, in a deal valued between 2 3 Billion USD. Guardian UAV technology will strengthen India in protecting areas under Indian Ocean.
- 13. USA approved selling one Boeing C-17 Globemaster transport aircraft to India at approx USD 366.2 million cost.

Economy

- 1. Indian Online financial services marketplace BankBazaar begun its operations in Malaysia to strengthen its presence in South East Asia.
- 2. According to Code Compliance Rating of banks done by Banking Codes and Standards Board of India (BCSBI)
- IDBI Bank is Only Bank out of 26 public sector banks to Get High Rating.
- 8 out of 17 private sector banks got *high* rating and 3 foreign banks (Citibank, HSBC and Standard Chartered Bank) Received High Rating.
- Code compliance rating is based on 5 parameters *information dissemination, transparency, grievance redressal, customer-centricity, and customer feedback.*
- 3. According to Handbook of Statistics on States 2016-17, gross fiscal deficits of all states has increased to INR 4,93,360 crores in 2016 from INR 18,790 crore in FY1991. This is 2nd edition of RBI's statistical publication.

- 4. According to Reserve Bank of India (RBI), India's current account deficit (net difference between inflows and outflows of foreign currencies) narrowed during 2016-17 to 0.7% of the GDP, from 1.1% in 2015-16.
- CAD came down due to India's trade deficit narrowing down to \$112.4 billion in 2016-17 from \$130.1 billion in 2015
- Net FDI inflows in 2016-17 also got narrowed to \$35.6 billion from \$36 billion during 2015-16
- 5. According to UNCTAD's World Investment Report 2017, US, China and India are top 3 FDI Receiving Destinations. FDI inflows into India remained USD 44 billion.
- 6. Asian Infrastructure Investment Bank (AIIB) approved \$150 million equity investment loan for India Infrastructure Fund as AIIB's first equity investment to fund private projects. IIIF will invest this amount in mid-cap infrastructure companies in India.
- 7. Axis Bank in association with Kochi Metro Rail Corporation (KMRL) has launched KMRL Axis Bank *Kochi1 Card* as India's first open loop EMV contactless metro card to make travel a convenient and hassle free.
- 8. Bank of India conducted a mass-contact programme *Star Mahotsav*, to contacting every customer at their doorstep for several activities including recovery of bad loans, disbursement of loans such as housing and vehicle loan, disbursement under MSME and agriculture etc.
- 9. Cabinet Committee on Economic Affairs approved strategic disinvestment of Air India and five of its subsidiaries.
- 10. Canara Bank inked Bancassurance pact with the *The New India Assurance Company Ltd*, to sell NIACL policies through its branches.
- 11. Employees Provident Fund Organisation (EPFO) signed MoU with Housing and Urban Development Corporation (HUDCO) to enable members of its housing scheme to avail subsidy and interest subvention under Pradhan Mantri Awas Yojana (PMAY). Under housing scheme, EPFO allows its subscribers for withdrawing up to 90 % of their EPF accumulations to buy homes.
- 12. European Union (EU) released final tranche of Euro 25 million of its euro 80 million grant to the Indian government's Sarva Shiksha Abhiyan and Rashtriya Madhyamik Shiksha Abhiyan (RMSA).
- 13. European Union released final tranche of Euro 25 million of its euro 80 million grant to the Indian government's Sarva Shiksha Abhiyan and Rashtriya Madhyamik Shiksha Abhiyan (RMSA).
- 14. Finance Ministry asked all ministries tasked with clearing foreign direct investment proposals in the 12 sectors that require government's nod to take a decision on such proposals within 60 days. It is being done to speed up the FDI Process.
- 15. GST Council constituted 18 Sectoral Groups representing various sectors of economy to ensure smooth implementation of GST by timely responding to the issues and problems of the respective Sector. GST Council also reduced the GST Rates of 66 items.
- 16. GST Council decided to set up a five-member anti-profiteering authority to decide on levying the penalty if businesses do not pass on the benefit of price reduction to consumers under GST regime.
- 17. Government approved Initial Public Offer of Indian Renewable Energy Development Agency Limited, for issuing 139000000 fresh equity shares of Rs.10 each to The public.
- 18. Government approved Securities and Exchange Board of India (SEBI) to enter into 2 separate MoUs with Securities market regulators of the European Union and Iran.
- 19. Government approved introducing *Financial Resolution and Deposit Insurance Bill 2017* that will provide resolution framework for financial sector entities to deal with bankruptcy situation in banks, insurance companies, and other entities
- It will also result in repealing of the Deposit Insurance and Credit Guarantee Corporation Act, 1961 to transfer the deposit insurance powers and responsibilities to the Resolution Corporation.
- 20. Government approved recommendations of 7th Central Pay Commission (CPC) on allowances -
- After examining total 197 allowances, 7th CPC recommended that 53 allowances be abolished and 37 be subsumed in an existing or a newly proposed allowance. Government decided not to abolish 12 of 53 allowances which were recommended to be abolished by 7th CPC. It has also been decided that 3 of 37 allowances recommended to be subsumed by 7th CPC will continue as separate identities.
- House Rent Allowance Currently paid @ 30% for X (population of Over 50 lakh), 20% for Y (5 50 lakh) and 10% for Z (below 5 lakh) category of cities. 7th CPC recommended reduction in existing rates to 24% for X, 16% for Y and 8% for Z category of cities.
- Other Allowances Include -
- Siachen Allowance Over 200 % Increase.
- Dress Allowance To be paid annually in four slabs @ Rs 5000, Rs 10,000, Rs 15,000 and Rs 20,000.
- Tough Location Allowance To be in the ranges of Rs 1000 Rs 5300 per month.
- Allowances paid to D/o Posts (Postmen / Trackmen) were recommended to be abolished by 7th CPC. However, These have been continued and Rates increased INR 90 to 180 per month.

- Recommendations of 7th CPC to abolish Launch Campaign Allowance and Space Technology Allowance have not been accepted. Rate of Launch Campaign and Space Technology Allowance has been increased from Rs 7500 to 11250 per annum.
- Fixed Medical Allowance (FMA) for Pensioners has been increased from Rs 500 per month to Rs 1000 per month
- Railways -
- Rates of Additional Allowance have been increased from Rs 500 / 1000 per month to Rs 1125 / 2250 per month. This has also been extended to Loco Pilot Goods and Senior Passenger Guards also @Rs 750 per month.
- New Allowance namely Special Train Controller's Allowance @5000 per month for Train Controllers of Railways has been introduced.
- Recommendations in respect of some important allowances paid to Nurses & Ministerial Staffs of Hospital Nursing Allowance increased from 4800 to 7200 per month. Operation Theatre Allowance increased from 360 to 540 per month.
- Uniformed Services (Defence, CAPFs, Police, Indian Coast Guard and Security Agencies) -
- 7th CPC had recommended abolition of Ration Money Allowance (RMA) and free ration to Defence officers posted in peace areas. However, this recommendation has not been accepted and Ration Money Allowance will continue to be paid.
- Most Other allowances have also seen considerable hike.
- Other Misc Alliowances -
- Children Education Allowance (CEA) increased from Rs 1500 per month / child (max 2) to Rs 2250 per month / child (max 2). Hostel Subsidy gone up from Rs 4500 to 6750 per month.
- Special Allowance for Child Care for Women with Disabilities has been doubled from 1500 to 3000 per month.
- Higher Qualification Incentive for Civilians increased from Rs 2000 10000 to 10000 Rs 30000.
- 21. Government has cut interest rates on farmers' loans by 5 % (earlier 9% to now 4%), on loan up to Rs 3 lakh. Farmers who do not pay interest in time, will have to pay interest at rate of 7 %.
- 22. Government has made Aadhaar card mandatory for government subsidy on purchase of kerosene and benefits of Atal Pension Yojana.
- 23. Government made Aadhaar mandatory for Opening bank accounts and Carrying out financial transactions above of Rs 50,000. All existing Bank accounts are to be linked to Aadhaar numbers by December 31, 2017.
- 24. HDFC Bank will impose new transaction charges on all outward UPI transactions from July 10, 2017. Transactions from Rs 1 25000 will be charged Rs 3 and transactions above Rs 25,000 to 1 lakh will be charged Rs 5.
- 25. HSBC (Hongkong and Shanghai Banking Corporation) Predicted India's GDP Growth To Remain 7.1 % In 2017-18. As per Official Data, India's GDP grew 6.1 % during January-March Quarter (Q4 2017) and GDP growth rate for full year (2016-17) remained 7.1 %.
- 26. India signed \$275 Million Loan agreement with Manila (Philippines) based Asian Development Bank (ADB) for improving urban services in 64 small towns in State of Madhya Pradesh.
- 27. India signed loan agreement of USD 35 million with World Bank for Assam State Public Financial Institutional Reforms Project.
- 28. Indian Overseas Bank (Lead Bank for Thiruvananthapuram district of Kerala) has launched *Retail Mart* as a retail lending concept in Thiruvananthapuram.
- 29. Insurance Regulatory and Development Authority of India (IRDAI) took over management of Sahara India Life Insurance Company as it was not acting in customer friendly manner. IRDAI appointed RK Sharma as administrator of Sahara India Life Insurance Company.
- 30. Kerala Passed State State Goods and Services Tax (SGST) Act, leaving J & K as only remaining state to not have passed State GST, which is to be implemented from July 01, 2017.
- Telangana was first state to Pass State GST (on 9th April 2017).
- 31. Largest Indian Bank State Bank of India has cut interest rate on home loans above Rs 75 lakh by 10 basis points (bps) to 8.60 percent (8.55 % For salaried women borrowers).
- 32. Leading bourse National Stock Exchange (NSE) launched its international exchange in the Gujarat International Finance Tec- City (GIFT City). NSE IFSC Ltd (global exchange promoted by NSE) will remain operational for a longer period than NSE during a trading day.
- 33. Markets regulator SEBI has barred USA Firm Cypress Money from acting as Investment Advisor as it was found guilty of providing unauthorized trading tips to investors.
- 34. NHB (National Housing Bank) approved merger of Wadhawan Family Owned Entities Aadhar Housing Finance and DHFL Vysya Housing Finance.
- 35. National Sample Survey Office (NSSO) under Union Ministry of Statistics and Programme Implementation released report *Key Indicators of Unincorporated Non-Agricultural Enterprises (Excluding Construction) in India* –
- Survey coveres non-agricultural enterprises which are not incorporated or not registered under Companies Act, 1956. It Includes, proprietary and partnership enterprises (excluding limited liability partnerships), Self Help Groups (SHGs), Non- Profit Institutions (NPIs) and Trusts etc.

- Results are based on sample consisting of 8484 villages and 7839 urban blocks spread over all States and Union Territories.
- During 2015-16, 6.34 crore unincorporated non-agricultural enterprises (excluding construction) were estimated at all India level with 11.13 crore workers. Out of These -
- 31 % are engaged in manufacturing, 36.3 % were in trading and 32.6 % in other services.
- Approx about 51 5 are in rural areas and 49 % in urban areas.
- Own Account Enterprises (OAEs) have a dominant share of 84.2 %.
- Pradesh has highest share of 14.20 % in total number of unincorporated non-agricultural enterprises (and workers), followed by West Bengal (13.99 % cent), Tamil Nadu (7.80 %), Maharashtra (7.54 %) and Karnataka (6.05 %).
- Operational Characteristics
- Proprietary enterprises had the highest share (96 %), Followed by Partnership enterprises (2 %), Self Help Groups (1.8 %).
- During 2015-16, aggregate GVA by the unincorporated non-agricultural enterprises engaged in market production was estimated at Rs 1152338 crores. Delhi reported the highest annual GVA per enterprise of Rs 497524 and West Bengal had the lowest GVA per enterprise of Rs 96686.
- Emoluments per hired worker stayed approx Rs 87544 annually. Kerala (Rs 125616) and Assam (Rs 53726) reported highest and lowest value of average annual emoluments per hired worker.
- 36. Pension Fund Regulatory and Development Authority (PFRDA) introduced "APY@eNPS" as a digital enrolment processfor Atal Pension Yojana (APY).
- 37. Private Bank DCB launched new services India's first Aadhaar based iris eye scan customer verification and fingerprint operated ATM in Telangana.
- 38. Private sector's Yes Bank partnered with mobile payments switch *TerraPay* to enable real-time money transfer to bank accounts in India. Yes Bank also tied up with messaging app Hike for Launching In-app Wallet.
- 39. RBI extended scope of Banking Ombudsman Scheme by enabling customers to lodge a complaint against defaulting bank for its non-adherence to RBI instructions with regard to mobile banking/electronic banking services. Pecuniary jurisdiction of Banking Ombudsman to pass an award has been also doubled to 20 lakh rupees.
- 40. RBI has placed Central Bank of India and Bank of Maharashtra under prompt corrective action (PCA) which puts restricts on banking activities such as from lending, hiring and expanding branches. RBI has so far triggered PCA for 6 banks IDBI Bank, UCO Bank, Dena Bank, Indian Overseas Bank, Central Bank of India and Bank of Maharashtra.
- 41. RBI identified 12 bank accounts constituting nearly 25% of gross bad loans for immediate referral and resolution under the bankruptcy law. Each of 12 identified accounts was having more than 5,000 crore rupees of outstanding loans.
- 42. RBI second bi-monthly monetary policy review of 2017 -
- Only change in Monetary Policy is that RBI has cut Statutory Liquidity Ratio (SLR) by 50 basis points to 20% (To be applicable from June 24, 2017). RBI reduced growth projection for the current fiscal to 7.3% from 7.4%.
- Monetary policy decision has been taken by the 6 member monetary policy committee headed by RBI Governor (Currently Urjit Patel).
- 43. Reliance Communications (RCom) and Aircel's Merged entity will be called Aircom. R-Com will demerge its wireless business and transfer it to the new entity Aircom. Merged company will be one of India's largest private sector companies with asset base of 65000 crores and net worth of 35000 crores.
- 44. Reserve Bank of India identified 12 non-performing accounts representing 25% of gross NPAs in Indian banking system, which will be immediately taken up under the Insolvency and Bankruptcy Code (IBC).
- 45. Reserve Bank of India initiated prompt corrective action (PCA) for Dena Bank in view of high net non-performing assets. In May 2017, RBI initiated PCA for IDBI Bank and UCO Bank for similar reasons.
- 46. Reserve Bank of India will release new batch of Rs 500 currency notes whose design will be similar to Rs 500 rupee banknotes of the Mahatma Gandhi (New) Series which were released post demonetisation. New batch of Rs 500 banknotes will have inset letter "A" in both the number panels.
- 47. SEBI allowed options trading on futures contract of commodities. However, capital market regulator allowed commodity derivatives exchanges to initially launch options on futures of only one commodity. Eligibility critreia for commodity exchanges to start trading in options contract of commodities —
- Only top 5 commodities in terms of total trading turnover value of previous 12 months will be allowed.
- Average daily turnover of underlying futures contract of such commodities over past 12 months should be minimum 200 crores for agricultural and agri-processed commodities, and 1,000 crore for other commodities.
- 48. SEBI asked Commodity derivatives exchanges to compulsorily set up investor protection and service funds, along with separate bank accounts for maintaining corpus of IPF and the ISF.
- Investor Service Fund (ISF) It is aimed at providing minimum facilities at various investor service centres. Initially, commodity exchange has to contribute at least Rs 10 lakh towards ISF. Subsequently, commodity exchanges will be required to transfer 1% of turnover fees charged from its members on monthly basis towards the ISF.

- Investor Protection Fund (IPF) It must have maximum 5 trustees. IPF will comprise of all penalties levied and collected by the commodity exchanges except for the settlement related penalties.
- 49. Securities and Exchange Board of India (SEBI) approved Telenor India's Merger with Bharti Airtel. The deal is now pending final approval by other authorities such as CCI (Competition Commission of India).
- 50. Software Firm Tata Consultancy Services (TCS) launched *BaNCS App Development Kit* (ADK), to enable banks to fast design and build their own apps and install it across devices and desktops. Vision for 'BaNCS ADK' is to transfer flexibility and increase speed of development in Banking.
- 51. State Bank of India (SBI) announced financing of solar rooftop projects worth 400 crores, adding over 100 MW of solar rooftop capacity. It is a significant step towards meeting India's target for 40 GW of solar rooftop installations.
- SBI had earlier availed loan of USD 625 million from World Bank for lending to Grid-Connected Rooftop Solar PV (GRPV) projects.
- 52. Uttar Pradesh Government signed agreement with Asian Development Bank (ADB) for loan of 1950 crore rupees for strengthening of roads in different districts.
- 53. Vijaya bank developed 5 villages into Digital Villages and plans to develop as many as 100 digital villages in various States.
- 54. World Bank approved USD 250-million loan for Skill India mission, aimed at making Indian youth more employable through reskilling. SIMO is a 6 year programme in support of National Policy for Skill Development and Entrepreneurship (2017-23). Under this, persons in age group of 15-59 will acquire skill training irrespective of their employment status. 55. World Bank's Global Economic Prospects (GEP) projected GDP growth rate of 7.2% for India in 2017-18 as against 6.8% growth in 2016-2017. World bank also expects India's growth rate to remain at 7.5% in 2018 and 7.7% in 2019. Global growth forecast in 2017 and 2018 at 2.7% and 2.9% respectively.

International

- 1. Mercer's 23rd annual Cost of Living Survey -
- Mumbai is most expensive city for expatriates in India, ranked 57th Globally, followed by New Delhi (99), Chennai (135), Bangalore (166) and Kolkata (184).
- Luanda (capital of Angola) is costliest city for expatriates globally, followed by Hong Kong and Tokyo.
- 2. 16th Global Retail Development Index (GRDI) 2017 The Age of Focus -
- India has been ranked at top among 30 developing countries on ease of doing business in retail sector.
- China has been ranked at 2nd place.
- 3. 2017 Social Progress Index report by Social progress Imperative (SPI) -
- India has ranked 93rd among 128 countries (Lower Middle Social Progress).
- Top 5 Denmark (1), Finland (2), Iceland (3, Norway (4), Switzerland (5)

- 4. 483-MW gas-steam Combined Heat and Power (CHP) plant, built by a China-Russia joint venture, officially started operations. It has been built at total investment of USD 571 million.
- 5. 6 Gulf Nations *Saudi Arabia, Bahrain, Egypt, Yemen, Libya and UAE* suspended their diplomatic ties with Qatar. They accused Qatar for supporting Terrorist Groups and such suscpicious activities.
- 6. World population Prospectus (The Revision) report by United Nations -
- India will become most populous nations by 2024, surpassing China. India's current population is 1.3 Billion and China is at approx 1.4 Billion.
- World's total population will hit 9.8 billion by 2050 and 11.2 Billion in 2020. Annually, 82 Million people are being added.
- Nigeria, which is currently at the seventh place is expected to become third most populous country by 2050 replacing USA.
- 7. A new wave of cyber-attacks with Name Petya Ransomware has infected computer servers across world.
- In India, This ransomware crippled operations at Jawaharlal Nehru Port Trust, operated by AP Moller-Maersk.
- Petya ransomware is a ransomware, similar to Wannacry ransomware. The attack is believed to have originated against an update used on a third-party Ukrainian software called MeDoc. This explains why Ukraine is the worst affected
- 8. According to Fitch group's Firm BMI Research India is among top 5 consumer markets in Asia offering retailers the strongest consumer spending growth of an average of 6.1% over next 5 years. Other four China, Sri Lanka, Vietnam and Indonesia. Fitch also estimated that India's GDP growth will rise from 7.4% to 7.5% in 2018-19 and to 7.6% in 2019-20.
- 9. According to London based coverage mapping firm OpenSignal -
- India has been ranked 74th (even below Pakistan and Sri Lanka) in terms of internet data speed with Average 4G download speed at 5.1Mbps. It is less than a third of global 4G average and marginally higher than global 3G speed of 4.4 Mbps. Average 3G download speed across India is less than 1 Mbps.

- Singapore scored highest in 4G speed while South Korea scored highest in 4G availability. Global average 4G download speed is 16.2 Mbps.
- 10. American E-Commerce Major Amazon acquired American Supermarket Firm *Whole Foods Market* for approx \$13.7 billion.
- 11. American Telecom giant Verizon acquired Yahoo's core business for \$4.48 Billion.
- Verizon will combine Yahoo with AOL which was bought by it two years ago to establish a venture called Oath.
- Remainder of Yahoo which is not acquired by Verizon will change its name to *Altaba Inc*. It will hold 15.5% stakes in Chinese Internet giant Alibaba and 35.5% holding in Yahoo Japan Corp. It will trade under ticker symbol "AABA."
- Thomas McInerney will be made as Altaba's chief executive officer.
- 12. As per One Family at a Time study conducted by UN International Fund for Agricultural Development (IFAD) -
- 20 Crore million migrants across world sent over USD 445 million in 2016 as remittances to their families.
- Top Remittance Receivers India (USD 62.7 billion), China (USD 61 billion), Philippines (USD 30 billion) and Pakistan (USD 20 billion).
- Top Remittance Sending Countries US, Saudi Arabia and Russia.
- 13. As per American commercial real estate services company Cushman & Wakefield -
- Hyderabad (Telangana) is ranked at top as a commercial office investment destination in APAC market.
- Total 6 Indian cities have been ranked in top 10 emerging investment destinations in APAC.
- 14. As per United Nations High Commissioner for Refugees (UNHCR), 6.56 crore people are either refugees, asylum seekers or internally displaced across globe by end of 2016.
- 15. Australia will launch online facility for filing visa applications by Indians from 1 July, 2017.

- Google named as most valuable brand US with Brand Value of \$235 Billion, Followed by Apple and Microsoft.
- 20. Brazil-Russia-India-China-South Africa (BRICS) grouping established a 1 million USD fund for boosting media cooperation, During BRICS Media Forum held in Beijing (China).
- 21. British PM Theresa May won confidence vote in parliament, winning her first major test as PM of a minority government in UK. She is now finally confirmed as British Prime Minister.
- 22. China and Asia Development Bank (ADB) launched a green financing platform to cut pollution in the smog-hit Beijing-Tianjin- Hebei region.
- 23. China is constructing world's first "Forest City" in Liuzhou, to be situated at 175 hectare land along Liujiang River. It is planned to be completed in 2020.

- 25. China launched its first X-ray Space Telescope named 'Insight' to study black holes, pulsars and gamma-ray bursts. This 2.5- tonne telescope will allow Chinese scientists to observe magnetic fields and the interiors of pulsars and better understand the evolution of black holes.
- 26. China launched its first X-ray space telescope Hard X-ray Modulation Telescope (HXMT), to study black holes, pulsars and gamma-ray bursts. It weighs 2.5 tonne and was sent to space using China's Long March-4B rocket.
- 27. China launched its first self-developed 'next-generation' bullet train 'Fuxing' with maximum speed of 400kmh.
- 28. China launched its most powerful naval destroyer Type 055, as one among largest warships in world.
- Type055 vessels will weigh more than 12,000 tonnes when fully armed, more than 8200 Tonnes *Project- 15B Visakhapatnam class destroyer* of Indian Navy which is yet to be commissioned.
- 29. China launched world's largest floating solar farm in Anhui province. This 40-megawatt power plant has 160,000 panels resting on a lake that emerged after the collapse of a coal mine in central Anhui province.
- 30. China unveiled world's first train that are battery powered and runs on a virtual track making use of sensor technology instead of metal rails.

- This train can reach top speed of 70 kmph. The train which is only about 32 metres long can carry up to 307 passengers.
- It has sensors that are capable of detecting the dimensions of the road permitting it to follow the routes without the need for metal rails. This new technology has been copyrighted by Chinese rail corporation.
- 31. China-led Asian Infrastructure Investment Bank (AIIB) approved membership of Argentina, Madagascar, and Tonga at its second annual meeting of Governors held in South Korea. It was attended by Finance and Defence Minister Arun Jaitley on India's Behalf.
- 32. Chinese archaeologists discovered *Fugan Temple*, which had been lost for over 1000 years in China's south-western Sichuan province.
- 33. Chinese scientists have developed world's most powerful submarine detector which could find hidden metallic objects, including minerals and submarines *superconductive magnetic anomaly detection array*.
- 34. Defence Minister Arun Jaitley visited Russia for 17th India-Russia intergovernmental commission on military technical cooperation meet and 1st India-Russia Joint Committee on Science and Technology Cooperation.
- 35. Denmark Government repealed a 334-year-old blasphemy law that forbids public insults of a religion. Denmark was only Scandinavian country with a blasphemy law that provisioned 4 months imprisonment for such acts.

- India is now 7th largest exporter of agri-products globally, with India representing over 12 % of total exports.
- Total merchandise exports during 2016-2017 are approx 276 billion USD, out of which agricultural exports are nearly 33 billion USD.
- 82 APEDA awards were presented for 2014-2015 and 2015-2016.
- 6. 22nd edition of European Union Film Festival (EUFF) started in Delhi with screening of Filmmakers Katrin Maimik and Andres Maimiks Estonian film "Cherry Tobacco".
- 7. 2nd edition of National Health Editors' Conference on Yoga held in New Delhi.
- 8. 31st anniversary of the signing of the historic Mizo peace accord on June 30, 1986 celebrated in Mizoram. Mizo Accord was signed by Mizo National Front (MNF) and Mizoram State Government. It bought peace in state after 20 years of violence and disturbance.
- 9. Vatsalya Maatri Amrit Kosh National Human Milk Bank and Lactation Counselling Centre has been opened at Lady Hardinge Medical College in New Delhi, as largest public sector human milk bank and lactation counselling centre in North India. It has been opened in collaboration with Norwegian government.
- 10. According to NGO Child Rights and You (CRY) Over 8 Lakh children are engaged in Child labour in India -
- Top 3 States with Most Children (aged 5 6) engaged in Child labour Uttar Pradesh (2.5 lakh), Bihar (1.3 lakh) and Maharashtra (83000 Thousand).
- 11. According to Oxford Poverty and Human Development Initiative (OPHI) Report about 31% of the world's *multidimensionally poor* children live in India (approx 2 crore). This is followed by Nigeria (8%), Ethiopia (7%) and Pakistan (6%). Amultidimensionally poor child is one who lacks at least one-third of ten indicators, grouped into three dimensions of poverty: health, education and standard of living.
- 12. Adani Group commissioned 50 megawatts (MW) solar photovoltaic (PV) plant in Mahoba (Uttar Pradesh). The plant has been set up with an investment of 315 crores under National Solar Mission Scheme.
- 13. An MoU signed between National Skill Development Corporation and Bird Academy for skilling of unemployed youth in the aviation and aerospace Sector. Under This, 30000 unemployed youth across various states including North Eastern states with special focus to train and empower minimum 5,000 women & tribal youths will be trained.
- 14. Andhra Pradesh government launched the AP MSME Development Corporation with a corpus fund of Rs 100 crore to promote micro small and medium enterprises (MSME) in State.
- 15. Arunachal Pradesh Government demanded for a separate time zone for northeastern states to improve work efficiency and save electricity in region.
- Recently, Bengaluru-based National Institute of Advanced Studies concluded that separate time zone for the northeastern region could help in saving 2.7 billion units of electricity every year.

- 16. Arunachal Pradesh government decided to increase retirement age of regular state government employees from 58 years to 60 years, to be implemented from 1st of January 2018.
- 17. As per Forbes, Aamir Khan starrer Dangal became first Indian movie to earn INR 2,000 crore worldwide. It also became 5th highest-grossing non-English film ever. Note That Major portion of Dangal's Finances came from China where it earned over 1300 Crores. Baahubali 2 is India's second highest grosser ever with 1700 Crores.
- 18. Bengaluru became first city where one can have fuel delivered at one's doorstep, owing to a Startup *Mypetrolpump*. Deisel can be received at doorstep with One rupee additional per litre.
- 19. CSIR-Structural Engineering Research Centre (Chennai) developed a cost-effective toilet, weighing under 500kg, life span of 25 30 years and can be assembled in 5 hours. It has been built with the help of textile reinforced concrete prototyping technology (TRCPT). TRC panels can be used as doors, roofing, walls and even flooring.
- 20. Central Council for Research in Yoga & Naturopathy (CCRYN) under Ministry of AYUSH initiated a Yoga Awareness Drive through Mascots and Flash Mobs (*YoqMob*) prior to International Yoga Day (21st June).
- 21. Central Government will soon replace Higher Education Bodies University Grants Commission (UGC) and All India Council of Technical Education (AICTE) with one Higher Education Regulator HEERA (Higher Education Empowerment Regulation Agency).
- 22. Central Industrial Security Force (CISF) and National Skill Development Corporation (NSDC) signed MoU, aimed at increasing employability of youth.
- 23. Central Reserve Police Force (CRPF) launched 24×7 helpline *Madadgaar* to help Kashmiri citizens at toll free number (14411).
- 24. Commerce & Industry Minister Nirmala Sitharaman launched *Startup India Virtual Hub* as an online platform for all stakeholders of entrepreneurial ecosystem in India to discover, connect and engage with each other.
- 25. Competition Commission of India (CCI), imposed fine of \$13.6 million on South Korean automaker Hyundai Motor's India Unit, accusing it of anti-competitive behaviour by imposing certain arrangements upon its dealers including monitoring maximum permissible discount level and mandating use of recommended lubricants and oils.
- 26. Directorate General of Civil Aviation (DGCA) suspended flying licence of Coimbatore-based carrier Air Carnival, which has not operated a single flight since early April.
- 27. Election Commission of India (ECI) announced that election for post of Vice-President of India will be held on 5 August 2017. Note that Elections for Post of President of India will be held on July 17.
- 28. Election Commission of India joined hands with Facebook to launch nationwide voter registration reminder, Between July 1- 4, 2017. Facebook will activate a unique (Register Now' button reminding all the eligible Indian users to enrol themselves as voters.
- 29. Elections for Electing 14th President of India will be held on 17 July 2017.
- 30. External Affairs Minister Sushma Swaraj inaugurated Know India Programme (KIP) for NRI and PIO youth, to provide them with an exposure to origin country.
- 31. First 50 MW unit of 100 MW Sainj Hydro Power project of Himachal Pradesh Power Corporation Limited (HPPCL) has been commissioned with northern grid through Parvati-Kol Dam transmission line.
- 32. First Mega Food Park in state of Odisha MITS Mega Food Park Pvt. Ltd. at Rayagada.
- 33. Food Safety and Standards Authority of India (FSSAI) issued draft regulations for organic food products to ensure the authenticity of organic foods, in view of rising demand for organic food products.
- Organic foods will have to comply with the government's provisions under the National Programme for Organic Production (NPOP) or the Participatory Guarantee System for India (PGS-India) run by Agriculture Ministry.
- 34. Goa CM Manohar Parrikar inaugurated 3 day MODI (Making of Developed India Festival) Fest in Panaji. Similar MODI fest was organized in Andhra Pradesh in First Week of June 2017.
- 35. Government launched a revamped oil and gas bidding mechanism named Open Acreage Licensing Process (OALP) and National Data Repository (NDR) for major oil field auctions to be held from 1 July. Auctions will be held under a new Hydrocarbon Exploration Licensing Policy (HELP).
- New bidding mechanism will allow interested firms to bid for blocks of their choice at any time of the year with the help of National Data Repository. NDR is a comprehensive database of India's key sedimentary basins that will provide the bidders data on contract areas that will be available for auctioning.
- 36. Government Owned Energy Efficiency Services Limited (EESL) will implement first project for rural LED street lighting in country under Government's Street Lighting National Project (SLNP). In first phase, 10 lakh conventional street lights with LED lights in Gram Panchayats of 7 districts in Andhra Pradesh. This will lead to reduction of 12 crore tonnes of CO2 and Approx 90 Crore INR Savings. Project is being funded by French Development Agency Agence Française de Développement (AFD).
- 37. Government approved constitution of Indian Naval Material Management Service (INMMS) as an organized *Group* 'A' Engineering Service.
- 38. Government approved setting up a new airport in Jewar in Greater Noida, which will cater 3 5 crore passengers per year over next 10 15 years.

- 39. Government launched *SPARROW-ITS* (Smart Performance Appraisal Report Recording Online Window) to enable Indian Trade Service (ITS) officers to fill their Annual Performance Appraisal Report (APAR) online for 2016-17 onwards.
- 40. Government launched a new training program *Comprehensive Online Modified Modules on Induction Training* (COMMIT) aimed at training State Government officials and improving public service delivery mechanisms. COMMIT will be launched in 6 States Initially Assam, Haryana, Maharashtra, Tamil Nadu, Telangana and West Bengal.
- 41. Government launched digital travel experience initiative *Digiyatra*. Digiyatra aims to digitally link unique IDs such as Aadhaar, passport or PAN card to the airlines' booking PNR to facilitate a seamless experience of passing through airports for the traveller that would also relieve queues and congestion.
- Essentially, system involves linking unique ID digitally at the time of booking to airline PNR. This would allow the passenger to have all the information required for smooth passage digitally.
- 42. Government notified that people suffering from tuberculosis will now have to submit their Aadhaar details to avail cash benefits for their treatment, under Revised National Tuberculosis Control Programme (RNTCP).
- 43. Government will appoint Nyaya Mitras to speed up the hearing of cases that have been pending in the lower courts for the last 10 years across country's courts.
- 44. Government's policy think-tank NITI Aayog drafted a New Energy Policy (NEP) and recomended to split 7 units of statecontrolled Coal India Limited (CIL) into independent companies, to bring in more competitiveness.
- About 70 percent of India's power generation is fired by coal. India is world's third-largest producer and third-biggest importer of coal.
- 45. Gujarat Government flagged off Astha Tourist Train, a special Gandhi Darshan train from Sabarmati railway station, On occasion of centenary celebrations of the historic Sabarmati Ashram founded by M K Mahatma Gandhi.
- Train will travel for 10 days (to and fro) to Bihar's Betitah and Motihari, formerly known as Champaran. Champaran was first place where M K Gandhi staged a satyagraha in 1917 in order to remove misery of indigo farmers.
- 46. Habibganj Railway Station (Bhopal, Madhya Pradesh) became India's first railway station to be redeveloped in a Public-Private Partnership (PPP) mode.
- 47. Haryana Government approved extension of Metro Rail from Narela in Delhi to Kundli in Sonepat district of Haryana with 3 new stations.
- 48. Hindi words Chana and Chana Dal are added to coveted Oxford English Dictionary (OED). *Chana* means Chickpeas and *Chana Dal* stands for split chickpea lentils.
- 49. India Meteorological Department (IMD) will launch forecasting system to give 15-day warnings on likelihood of a malaria or chikungunya outbreak across country.
- 50. India ratified 2 fundamental Conventions of the International Labour Office (ILO) concerning elimination of child labour *Minimum Age Convention*, 1973 (No 138) and *Worst Forms of Child Labour Convention*, 1999 (No. 182).
- 51. India signed Loan Agreement for part funding of USD 240 million from World Bank (IBRD) and USD 160 Million from AIIB (60:40 ratio) for 24X7 Power for All in Andhra Pradesh Project.
- 52. India signed USD 39.2 Million Loan agreement with World Bank for Assam Citizen Centric Service Delivery Project.
- 53. India's textile and fashion heritage became part of Google project 'We Wear Culture'. India's Such vast fashion heritage can now be explored through Google's latest virtual exhibition project We Wear Culture.
- 54. Indian Institute of Technology Kharagpur developed a wireless technology called *AmbuSens*, meant for remote monitoring of condition of patients who are ferried in ambulances. Patients will be fitted with wireless body sensors, which will enable monitoroing parameters like ECG, heart-rate, temperature and blood-pressure at a remote location.
- 55. Indian Railways started final location survey of 498 km long Bilaspur-Manali-Leh line at Leh in Jammu and Kashmir.
- Bilaspur-Manali-Leh line at Leh in Jammu and Kashmir at height of 3,300 metres will be highest rail track in world, overtaking China's Qinghai—Tibet Railway.
- 56. Indian Railways will reduce emission by 33 % by 2030, by involving several green initiatives and promoting low carbon mass transportation system -
- Railways aims to achieve 1000 MW of solar power and 170 MW of wind power installed capacities.
- Another mainstream target is to Fit bio-toilets in its strong fleet of 55,000 coaches by 2019.
- 57. Indian Railways' 1st HR Round Table Conference held in New Delhi.
- 58. Indian Space Research Organisation (ISRO) launched heaviest rocket ever made by India, Geosynchronous Satellite Launch Vehicle Mark III (GSLV Mk- III) on 5 June 2017.
- It is called Fat Boy, as it is India's heaviest (640 tonnes) but smallest rocket (43 metres).
- It will enable India to send Manned missions to Space. Only 3 Other nations are currently able to do so US, Russia and China.
- It will be able to place 4-tonne class satellites into Geosynchronous Transfer Orbits (much more than previous rocket's capacity of 2-tonne class).
- It will have New indigenous cryogenic engine, developed by the Liquid Propulsion Systems Centre of ISRO. A cryogenic engine provides more thrust for every kilogram of cryogenic propellant (liquid hydrogen or liquid oxygen) that it burns. 59. Indore (Madhya Pradesh) became first city in India where robot is being used on an experimental basis to control its ever growing and unruly traffic.

- 60. Inland Waterways Authority of India (IWAI) will develop country's first 'freight village' spread over around 100 acres in Varanasi (Uttar Pradesh).
- 61. J P Nadda (Minister for Health and Family Welfare) launched *Skill for Life, Save a Life* initiative, to promote skill development in the health sector.
- 62. Karnataka Goverment launched India's first public bicycle sharing (PBS) initiative 'Trin Trin' in Mysuru, jointly funded by World Bank, Global Environmental Fund and state govt. Mysuru is the first city in India to have a public bicycle sharing system.
- 63. Kerala State government announced a green protocol to make weddings in state more nature-friendly. Under This, plastic and other non-biodegradable articles including disposable glasses and plates and thermocol decorations will not be permitted to be used in weddings.
- 64. Madhya Pradesh government launched debt relief scheme *Krishi Rin Samadhan Yojana* for farmers, allocating INR 1000 crores for this. It Provisons -
- Interest Subsidy.
- Compensation 1 crores for passed away farmers and 5 Lakh for injured.
- 65. Maharashtra CM Devendra Fadnavis launched web portal *Mahaswayam*, to cater to job seekers, employers, entrepreneurs, and training institutes who can avail details regarding skill development and employment.
- 66. Maharashtra Government announced launching of a mobile app named 'My Plant', that would help in recording data regarding tree plantations in state. Maharashtra state government also appealed its employees to contribute a day's salary to provide financial assistance to families of farmers in suicide-prone regions.
- 67. Mahesh Sharma (Minister of State (IC) for Culture & Tourism) launched *National Mission on Cultural Mapping of India* in Mathura (Uttar Pradesh). It is part of *Ek Bharat Shreshtha Bharat* program and aims at converting widespread cultural canvas of India into an objective cultural map.
- 68. Manipur CM Biren Singh launched a toll free 24/7 helpline number 181 for women in state .
- 69. Meghalaya Assembly passed a resolution demanding immediate withdrawal of Centre's notification banning sale and purchase of cattle from animal markets for slaughter, calling it an *infringement* of rights of states.
- 70. Meghalaya government signed 2 MoUs with State Bank of India as part of migrating government transactions to digital mode. State government will now escalate its transactions for the collection of tax and non-tax revenue through the online system Government Receipt Accounting System (GRAS) covering all departments in a phased manner.
- 71. Minister for Urban Development and Housing & Urban Poverty Alleviation M. Venkaiah Naidu announced new batch of 30 smart cities under Smart City Mission, taking number of total cities picked up under Smart City Mission up to 90.
- 72. Minister of Railways Suresh Prabhu launched Mission Retro-Fitment to enhance passenger experience by upgrading 40000 existing coaches.
- Refurbished coaches will have better amenities and safety features, aimed at providing comfortable travel to railway passengers.
- 40,000 coaches will be refurbished and retrofitted over 5 years. Mission also aims to induct 40,000 new coaches with upgraded interiors by 2022-23.
- It is estimated that cost of refurbishing per coach to be approximately Rs 30 lakhs.
- 73. Minister of Road Transport & Highways and Shipping Nitin Gadkari launched *INAM-Pro +* web portal, for Sale and Purchase of Construction Material and Service.
- 74. Minister of State for Power, Coal, New and Renewable Energy and Mines launched Energy Conservation Building Code 2017 (ECBC 2017).
- This updated version of ECBC prescribes energy performance standards for new commercial buildings to be constructed across India.
- ECBC provides present as well as futuristic advancements in building technology to cut down building energy consumption and promote low-carbon growth. It sets criteria for builders, designers and architects to integrate renewable energy sources in building design through inclusion of passive design strategies.
- To be ECBC-compliant, the new buildings should be able to demonstrate minimum energy savings of 25%. Energy savings of 35% and 50% will enable the buildings to achieve higher grades like ECBC Plus or Super ECBC status respectively.
- Adoption of ECBC 2017 will achieve 50% reduction in energy use by 2030 which will translate into energy savings of about 300 Billion Units by 2030.
- 75. Ministry of Health and Family Welfare launched Intensified Diarrhoea Control Fortnight (IDCF) to intensify efforts to reduce child deaths due to diarrhoea. Aim is to mobilize health personnel, State Governments and other stakeholders to prioritize investment in control of diarrhoea.
- 76. Ministry of Law and Justice approved *Prevention of Cruelty to Animals (Karnataka Amendment) Bill 2017*, to allow Kambala Sport in Karnataka State that Involves Bulls. Karnataka high court November 2016 banned kambala along with bull-cart race in state.
- 77. Ministry of Law and Justice has launched *Tele-Law* initiative in collaboration with Ministry of Electronics and Information Technology to provide legal aid services to citizens living in rural areas through Common Service Centres

- (CSC) at panchayat level. With this, people can seek legal advice through video conferencing facility at Common Service Centres (CSC).
- 78. Ministry of Rural Development confrred 144 awards under various categories to states and other organisations, to highlight commendable work done under various schemes of Rural Development Ministry. Notable awards included Bihar that was awarded for constructing most number of rural roads and Madhya Pradesh was awarded for use of nonconventional construction material in road construction under 'Pradhan Mantri Gram Sadak Yojana' (PMGSY).
- 79. Mizoram Government launched *Test and Treat Strategy* of Mizoram state AIDS Control Society (MSACS) to improve treatment for HIV affected people in state. Under this, HIV-affected people would be given free Anti Retrovira Therapy (ART) irrespective of CD4 count.
- 80. Mumbai's Taj Mahal Palace hotel acquired *image trademark* under Trademark Act 1999, making it first building in India to acquire intellectual property rights protection for its architectural design. Henceforth, image of Taj Mahal Palace hotel's dome and exterior can be used only with consent of Taj Hotels Palaces Resorts Safaris.
- 81. NITI Aayog chosen CSIR-Centre for Cellular and Molecular Biology (Hyderabad) for hosting the Atal Incubation Centre for biotechnology start-ups. CCMB is one of 10 organisations identified to host *Atal Incubation Centres*. Government will release aid of 10 crores for upto 5 years.
- Atal Innovation Mission (AIM) under NITI Aayog is aimed at promoting innovation and entrepreneurship in India. Under It, Atal Incubation centres would encourage start-ups in various sectors.
- 82. NITI Aayog launched SATH *Sustainable Action for Transforming Human capital* with State Governments for strengthening agenda of cooperative federalism. Under this, Government will identify and build 3 future 'role model' states for health systems.
- For Health Sector, shortlisted states are Uttar Pradesh, Bihar, Assam, Karnataka and Gujarat. For Education Sector, shortlisted states are Madhya Pradesh, Odisha, Chhattisgarh, Jharkhand and Andhra Pradesh.
- 83. Nalanda University (Bihar) signed MOU with South Korea's Academy of Korean Studies for academic cooperation. Two universities have agreed to enhance the bilateral ties through joint research programme.
- 84. Narmada Control Authority (NCA) approved final raising of Sardar Sarovar Dam (SSD) in Gujarat by lowering of gates and impounding of water in reservoir up to its Full Reservoir Level (FRL) of EL 138.68 meters.
- 85. National Aviation University (NAU) signed MoU with Bird Worldwide Flight Services (India) Private Limited to develop professional aviation and aerospace education programmes for benefit of Indian civil aviation industry.
- 86. National Legal Services Authority (NALSA) launched Web Application for freelegal services to prisoners and Legal Services Management System.
- NALSA has responsibility to provide legal aid inter-alia to all persons in custody.
- 87. National Mission for Clean Ganga (NMCG) approved projects worth INR 1900 crores for creation of sewage treatment infrastructure in Haridwar, Rishikesh, Vrindavan, Varanasi, Allahabad and Delhi.
- 88. National Thermal Power Corporation (NTPC) launched India's first 150 kWp canal top solar PV System on cooling water (CW) channel at 2,320 MW Mouda Thermal Power Project in Maharashtra.
- 89. National Workshop on Empowerment of Farmers of Tribal Areas in delhi.
- 90. Odisha became first state to open a blood bank for cattle, which is to be set up soon onpremises of Odisha University of Agriculture and Technology (OUAT).
- 91. Odisha state government approved 53 urban projects with a total investment of Rs 538 crore under Atal Mission for Rejuvenation and Urban Transformation (AMRUT).
- 92. Odisha will commission Early Warning Dissemination System (EWDS) in July, as First Such system in country to warn state's residents along its 480 km-long coast in the event of natural disasters like a tsunami / cyclones.
- Warning will be issued just by pressing a button from a control room in event of occurrence of natural disasters. It would trigger loud sirens simultaneously from towers at 122 locations including tourist destinations.
- 93. Oil and Natural Gas Corporation (ONGC) and United Nations Educational, Scientific and Cultural Organization (UNESCO) carried joint survey for conservation of Chilika Lake (Odisha), to make it gain world heritage site tag. 94. On Occasion of completion of 3 Years of NDA Government, Making of Developed India (MODI) festival held in Andhra Pradesh.
- 95. PM Narendra Modi inaugurated Kochi Metro as 8th Inter-City Metro rail Project in India (first in Kerala).
- DMRC (Delhi Metro Rail Corp) completed its construction in 4 years.
- First phase is 13.2 km long and is India's first integrated multi-mode transport system. System will also provide boat rides with water transport as a feeder service to rail corridor.
- Kochi Metro is first public transport system to have reserved jobs for transgenders.
- 96. PM Narendra Modi inaugurated centenary celebrations of Sabarmati Ashram in Ahmedabad (Gujarat). He also released the coin and postal stamp in the honour of Jain saint and philosopher Shrimad Rajchandra on his 150th birth anniversary.
- 97. PM Narendra Modi inaugurated various irrigation and water-related initiatives at Aji Dam in Rajkot (Gujarat), including filling of Aji dam with Narmada waters under Sauni Yojana.
- 98. Piyush Goyal (Minister of State (IC) for Power, Coal, New & Renewable Energy and Mines) launched -

- Weather Portal for Power Sector in association with POSOCO and IMD. Information in Portal regarding weather forecast shall help State Discoms to take pro-active steps regarding short term and medium term management processes.
- Portal *MERIT* (Merit Order Despatch of Electricity for Rejuvenation of Income and Transparency) to store and display information regarding merit order of Electricity procured by State(s) such as daily state-wise marginal variable costs of all generators, daily source-wise power purchases of respective states/UTs.
- 99. President Pranab Mukherjee launched mobile Application *Selfie with Daughter*. The *Selfie with Daughter* campaign was started by Sunil Jaglan in June 2015 in Haryana.
- 100. Public Sector Oil Marketing Companies Indian Oil, Bharat Petroleum and Hindustan Petroleum will set up world's largest refinery and petrochemical complex in Ratnagiri district of Maharashtra.
- Indian Oil will hold 50% stake and Hindustan Petroleum Corp Ltd (HPCL) and Bharat Petroleum Corp Ltd (BPCL) will each hold a stake of 25% each in the new complex.
- Refinery will be set up at estimated cost of Rs 3 lakh crore and will completed by 2022. It will have 60 million tonnes refining capacity.
- 101. Punjab Government announced free education for girls in government schools and colleges from Nursery to Ph.D. Note That Reservation for women in Panchayati Raj Institutions and Urban Local Bodies has already been increased from 33 to 50 %.
- 102. Punjab Government presented state budget of Rs 1.18 lakh crore for FY 2017-18 -
- It focuses on reducing crushing debt burden and restoring fiscal stability.
- Total waiver of crop loans for small and marginal farmers has been announced by Punjab Government.
- 103. Punjab government and United Kingdom join hands for imparting skill training and technical education to the students to provide better employment opportunities in abroad.
- 104. Punjab government launched *Chief Minister Scholarship Scheme*, aiming to provide cheaper and quality technical education to the meritorious and poor students of the state.
- 105. Railways launche *Operation Swarn (gold)* aimed at improving services in premium trains like Rajdhani and Shatabdi Express. It has been initiated after several complaints received from passengers about services rendered in these premium trains. In first phase, Mumbai-Delhi Rajdhani Express and Mumbai-Ahmedabad Shatabdi Express will be upgraded.
- 106. Railways will soon implement satellite-based chips in Trains, Devveloped by ISRO.
- These Chips will enable sending alert people and Train Drivers at unmanned rail crossings. Initially these will be installed in Mumbai and Guwahati Rajdhani trains. - 116. Syama Sanju has been declared as *Queen of Dhwayah*, winner of Kerala's first ever beauty pageant for transgender women.
- 117. Tamil Nadu government announced free education for transgender community in all colleges of state's Manonmaniam Sundaranar University.

- 118. Telangana government launched single-women pension scheme across state. Under this, pension of about 1000 / month would be given to single women on humanitarian grounds. This is the first such welfare scheme by any state in India.
- 119. Telangana government launched website to facilitate online sale or purchase of cattlepashubazar.telangana.gov.in. It will help farmers as the cattle need not be brought to shandies every time and farmers can save on transportation cost on cattle.
- 120. Telecom Regulatory Authority of India (TRAI) launched 3 new apps to help customers rate quality of services, speed and performance Mycall, MySpeed and 'Do not disturb (DND 2.0)' app.
- 121. To attract more passengers to buy online train tickets, Indian Railways introduced a service 'Buy Now, Pay Later' which allow passengers to make payment for tickets booked online within 15 days. IRCTC tied up Fintech Firm *ePayLater* for this service.

- 1. A new summer variety of groundnut has been developed by agro-scientists of the Chandra Shekhar Azad Agriculture Technology University (CSA) at Khanpur in Uttarpradesh.
- This Summer variety of groundnut is disease-free as pests cannot attack the crop because of high temperature. Now, during summer people will not have to consume stored groundnuts grown during winter season.

- 2. According to *Animal Discoveries 2016 New Species and Records* report by Zoological Survey of India and Plant Discoveries 2016, 499 new species have been discovered from various parts of the country last year. Number of animal species in Insia for the first time has crossed one lakh to number 1,00,693.
- 3. China successfully tested a solid-fuel variable flow ramjet engine that could enhance the real combat ability of the country's stealth aircraft and boost firing range of missiles. Ramjet engine has advantage of low cost, high power, and high controllability with compact size.
- 4. China launched record breaking swarm (Group) of 119 fixed-wing drones (unmanned aerial vehicles), breaking previous record of a swarm of 67 drones. These drones performed catapult-assisted take-offs and formations in sky.
- 5. China will send mini-ecosystems comprising of potato seeds and silkworm eggs to Moon in 2018, along with Chang'e 4 Satellite.
- 3-kilogramme mini-ecosystem will be developed by research teams under Chongqing University in China.
- 6. Indian Space Research Organisation (ISRO) is working on Electric Propulsion (EP) system a new propulsion system that may bring new era of cost effective satellite launches. It converts solar energy into electrical energy which is used to change velocity of a satellite in space.
- 7. Indian Space Research Organization (ISRO) successfully launched Cartosat-2E weighing 712 KG (Earth observation satellite) along with 30 co-passenger satellites of various countries, aboard Polar Satellite Launch Vehicle (PSLV) C-38.

 8. India's latest communication satellite GSAT-17 successfully launched from Kourou in French Guiana (France), with a lift-off mass of about 3,477 kg and payloads in C-band and S-band to provide various communication services.
- 9. Laser Interferometer Gravitational-Wave Observatory (LIGO) detected another merger of 2 black holes forming gravitational waves, Named as GW170104. This time, detection revealed not merely a black hole merger, but also alignment of spins of black holes. This can help in finding out the way black holes were formed.
- 10. NASA Annouuced to launch James Webb Space Telescope (JWST) in October 2018 -
- James Webb Space Telescope JWST is a joint project of the NASA, the European Space Agency and the Canadian Space Agency. It will be successor of 26-year-old Hubble Space Telescope and is 100 times powerful than Hubble Space Telescope.
- JWST will be the largest telescope ever sent into space. It will have a very large infrared telescope with a 6.5-meter primary mirror with sun shield of 22 metres.
- JWST is named after former NASA administrator *James Webb*, formerly known as *Next Generation Space Telescope* (NGST).
- As JWST's First set of Targets 2100 observations has been planned by JWST mission handlers.
- Another NASA Spacecraft *Orion* also cleared Tests. It is meant to carry astronauts to deep space destinations like Moon and Mars.
- 11. NASA launched world's lightest satellite weighing only 64 grams designed by 18-year-old boy Rifath Sharook from Tamil Nadu.
- Satellite has been named as KalamSat after the former President APJ Abdul Kalam.
- KalamSat is a 3-D printed satellite. This is the first time that 3-D printing technology is used to make satellites. Purpose of launching KalamSat is to demonstrate performance of 3D-printed carbon fibre.
- 12. NASA tested ROSA (Roll-Out Solar Array) successfully on ISS (International space station) for first time.
- ROSA is an advanced, flexible solar array that rolls out like a tape measure. It is very much flexible ad Light weighted so that it can be adapted to different sizes including very large arrays.
- ROSA will be an asset for satellite radio and television, weather forecasting, GPS and other services used on Earth.
- Unlike Bulky and large traditional solar array panels, ROSA can make solar arrays more compact and weigh lighter.
- 13. NASA will launch Terrier-Improved Malemute sounding rocket that will release blue-green and red artificial clouds, to support space studies.
- 14. NASA will soon launch Neutron Star Interior Composition Explorer (NICER), world's first ever mission devoted for studying neutron stars. NICER will focus especially on Pulsars and will also carry out world's first demonstration of X-ray navigation in space.
- 15. NASA's Kepler Telescope has identified 10 Earth-like planets outside the solar system that are expected to host life due to their right size and temperature. This discovery is part of 219 new planets identified by Kepler telescope as part of the final batch of planets since Kepler was launched in 2009.
- 16. NASA's Mars rover *Opportunity* found rocks at edge of Endeavour Crater that might have been a lake of liquid water. Opportunity has been investigating near Endeavour Crater since 2011, which is about 22 km across.
- 17. Scientists at USA's University of Nebraska-Lincoln created brightest light ever produced on Earth, shining a billion times stronger than surface of sun.
- Normally an electron scatters just 1 photon of light at a time but the new light beam produced saw over 1000 photons scattered at a time.
- It could be used as a new type of X-ray and also by engineers, scientists and for security purposes.

- 18. Scientists discovered a new species of flying squirrel named *Glaucomys Oregonensis* in North America, that had been hiding in plain sight for over hundreds of years. Known as Humboldt's flying squirrel, this new species resides in the Pacific Coast region of North America.
- 19. Scientists discovered hottest known exoplanet KELT-9b.
- Exoplanet is a planet that does not orbit the Sun and instead orbits a different star.
- The Planet orbits a massive star KELT-9 with day temperature approx 4,326 degree Celsius.
- 20. Scientists reportedly solved centuries-old unexplained mystery of *bright nights*, the unusual glow that appears in sky after dark and lets observers see distant mountains, read a newspaper or check their watch.
- Researchers suggest that when waves in upper atmosphere converge over specific locations on Earth, it amplifies naturally occurring airglow, a faint light in the night sky that often appears green due to the activities of atoms of oxygen in the high atmosphere.
- 21. US Space exploration firm SpaceX's Falcon rocket lifted off carrying Dragon capsule, which was loaded with nearly 6000 pounds of scientific research and station supplies. It is the second time the Dragon has been sent to ISS, becoming First ever Recycled Supply Ship sent to ISS.
- 22. World's first hybrid 'aeroboat' which has been built by an Indo-Russian joint venture unveiled at an event by Russia's Skolkovo Foundation. It is capable of travelling on land, water, snow and sand and is capable of moving at the speed of around 150 kmph or more on water.
- 23. World's oldest fossil mushroom discovered in Brazil, dating back zpprox 115 million years. It has been named as Gondwanag Aricites Magnificus and repprtedly belongs to Agaricales order.
