2. May 01 - Statehood Day of Maharashtra and Gujarat. It commemorates formation of Maharashtra and Gujarat from division of the Bombay State on 1 May 1960.

3. May 02 - World Tuna Day. 2018 theme is *Smart Tuna – Smart Ocean*.

4. May 03 - World Press Freedom Day. was observed across the world on May 3, 2018 with an aim to celebrate the fundamental principles of press freedom, defend the media from attacks and pay tribute to journalists who have lost their lives while being on duty. The Theme for 2018 is 'Keeping Power in Check: Media, Justice and The Rule of Law'.

5. May 1 - World Asthma Day. 2018 theme is *Never too early, never too late. It's always the right time to address airways disease.*

6. May 1 - International Workers' Day, also known as Labour Day AND May Day. 2018 Theme is *Uniting Workers for Social and Economic Advancement.*

- On 11th May 1998, India carried out series of nuclear tests at Pokhran. Also first indigenous aircraft "Hansa 3" was test flown on this day and India also performed successful test firing of Trishul missile on same day.
- Considering these technological advancements, then Prime Minister Atal Bihari Vajpayee declared 11th May as National Technology Day.

- On this occasion, Atal Tinkering Marathon's Top 30 Innovations to be supported through industry partnerships were showcased. Atal Tinkering Labs of Atal Innovation Mission (AIM) of NITI Aayog organized an Atal Tinkering Marathon in an effort to identify India's best student innovators. It was six month long nationwide challenge across 6 thematic areas – *clean energy, water resources, waste management, healthcare, smart mobility and agriculture-tech.*

8. May 12 - International Nurses Day (IND). It marks birth anniversary of Florence Nightingale, founder of modern nursing. 2018 theme is *Nurses: A Voice to Lead – Health is a Human Right*. On this occasion, President conferred National Florence Nightingale Awards to nursing personnel from across country.

9. May 12 - World Migratory Bird Day (WMBD). 2018 theme is Unifying our Voices for Bird Conservation.

10. May 15 - International Day of Families. 2018 theme is Families and inclusive societies.

14. May 18 - International Museum Day. 2018 theme is *Museums and Hyper Communication – New Approaches and New Public*. It is also observed as AIDS Vaccination day.

15. May 20 - World Metrology Day. 2018 Theme is *Constant evolution of the International System of Units*. 16. May 21 - Anti Terrorism Day. It marks assassination of Former Prime Minister Rajiv Gandhi in 1991. It is also observed as *World Day for Cultural Diversity for Dialogue and Development*.

17. May 22 - International Day for Biological Diversity. 2018 theme is *Celebrating 25 Years of Action for Biodiversity*.

- On this occasion, National Mission for Clean Ganga and World Wildlife Federation (WWF) - India jointly organised workshop *Ganga and its Bio-diversity: Developing a Road Map for Habitat and Species Conservation* in New Delhi. Also, national-level celebrations were held at Prof. Jayashankar Telangana State Agricultural University (PJTSAU) in Hyderabad.

- On this occasion, India Biodiversity Awards 2018 were announced in 4 categories -

- Conservation of Wild and Domesticated Species -

- Singchung Bugun Village Community Reserve Management Committee (Arunachal Pradesh) – For Conservation of Bugun Liocichla, a critically endangered bird.

- Lemsachenlok Organization (Nagaland)

- Kutch Unt Uchherak Maldhari Sangathan (Gujarat) - Conservation of Kharai camel. which is unique for its ability to adapt well to both terrestrial and marine ecosystems.

- Kalden Singhi Bhutia (Sikkim) - For conservation of Tibetan sheep.

- Sustainable Use of Biological Resources -

- Sangham Women Farmers Group (Medak district of Telangana) - Working towards conservation of agrobiodiversity for 15 years.

- Parvathi Nagarajan - (Tamil Nadu) - Works for environment protection, wellness and women's empowerment.

-Raipassa Biodiversity Management Committee (Tripura) - Community depends on cultivation, collection and sale of broom grass for its livelihood. Villagers collect about 50 tonnes of broom grass per season, and sell it at Rs. 22/Kg.

- Replicable Mechanisms for Access and Benefit Sharing

- Best Biodiversity Management Committees -

- Eraviperoor Grama Panchayat (Kerala) - is an excellent model of a multi-stakeholder partnership in local biodiversity conservation. BMC has rejuvenated a tributary of river Pampa, successfully recovered 13.5 acres of river bank and shown exemplary work in plastic waste management.

- Pithorabad Grama Panchayat (Madhya Pradesh) - Sustained efforts towards the conservation and sustainable utilization of bio-resources. It conserves around 115 traditional types of paddies, 32 varieties of vegetables, and medicinal plants.

27. May 6, 2018 - World Laughter Day 2018. It is celebrated on First Sunday of May of every year.

28. May 7, 2018 - 58th Raising day of Border Roads Organisation (BRO). It is also observed as World Athletics Day.

29. May 8 - World Red Cross Day. Theme of 2018 is *Memorable smiles from around the world*.

Defence

1. Aeronautical Development Agency (ADA) invited private players in Coimbatore (Tamilnadu) for building Advanced Medium Combat Aircraft (AMCA), the next generation defence aircraft. Project will be implemented in Sulur in Coimbatore district, which may house permanent base of Tejas squadron.

2. Central Reserve Police Force (CRPF) commissioned special unit called Bastariya Battalion (numbered 241) to combat Naxals activities in Bastar region of Chhattisgarh. This is first such time that CRPF has raised a special battalion that includes local representation to enhance combat capabilities.

- 241 Bastariya Battalion comprises 739 local tribal youths including 198 women combatants selected through special recruitment drive from four highly Naxal infested district in Chhattisgarh - Bijapur, Dantewada, Narayanpur and Sukma.

3. Chetak corps of South Western Command of Indian Army conducted military exercise Gandiv Vijay in Rajasthan.

4. Dakota DC-3 aircraft of 1940's vintage named as 'Parshuram' has been again Inducted into Indian Air Force, after over 40 years of phasing out.

5. Defence Acquisition Council (DAC) approved procurement of equipment for Defence Forces valued at INR 6900 crores. It Includes -

Thermal Imaging (TI) Night Sights for Rocket Launcher (RL) used by Army and the Force under 'BUY(Indian)
 IDDM' category, to be used by troops to facilitate accurate engagement of enemy targets complete darkness.
 Development of Long Range Dual Band Infrared Imaging Search and Track System (IRST) for SU-30 MKI aircraft under 'Make II' sub category, for procurement of at least 100 IRSTs under 'Buy (Indian–IDDM) category.

6. Fourth Landing Craft Utility (LCU) Mk-IVclass, LCU L54 has been inducted into Indian Navy. Remaining 4 ships of same class are in advanced stages of construction at GRSE, Kolkata.

7. Home Minister Rajnath Singh announced family of a paramilitary jawan who dies in action will be given a minimum compensation of 1 crore rupees.

8. India concluded price negotiations with Russia for deal to procure S-400 Triumf air defence missile systems for Indian Air Force (IAF), with finalised financial component nearly Rs 40,000 crores.

- Now, both countries are trying to find way out to evade provisions of CAATSA (Countering America's Adversaries Through Sanctions Act), a US law that seeks to punish countries and entities engaged in transactions with defence establishment of Russia. USA announced sanctions against Russia under CAATSA for its alleged meddling in presidential election in 2016.

- S-400 Triumf Air Defence SystemIt is long-range air defence missile system is one of most advanced long range defence systems in world, manufactured by Almaz-Antey. It It has capability to destroy incoming all airborne targets at ranges of up to 400 km.

9. India successfully test fired BrahMos supersonic cruise missile, to validate it as first Indian missile whose life has been increased from 10 to 15 years.

- BrahMos cruise missile developed by joint-venture between Russia's Mashinostroyenia and India's Defence Research and Development Organisation (DRDO), named after Brahmaputra river in India and Moskva river in Russia.

- It is capable of carrying warhead of 300 kilogram (conventional / nuclear) with top speed of Mach 2.8 to 3 (thrice the speed of sound).

- Its range was initially capped at 290 km, now incresead to 450 km after India's entry into MCTR (Missile Technology Control Regime). It is planned to rise to 600km soon.

10. Indian Army finalised INR 15000 crores indigenous ammunition project under which range of ammunition for its critical weapons and tanks will be produced indigenously. It aims to cut dependence on imports and create inventory to enable forces to fight 30-day war. 11 private firms will be involved and implementation will be monitored by Defence Ministry.

11. Indian Army's South Western Command conducted month long Vijay Prahar exercise in Suratgarh (Rajasthan).

Indian Coast Guard commissioned ICGS Vikram, first of seven new-generation offshore patrol vessels.
 Indian Naval Sailing Vessel Tarini (INSV Tarini) entered Goa harbour, after completing a historic global circumnavigation voyage by an all-women crew. Crew Members of this expedition were presented Nari Shakti Puraskar 2017 by Govt.

- Titled Navika Sagar Parikrama, The 254 days long expedition was flagged off in Goa on September 10, 2017. 6 members are - Vartika Joshi (Skipper), Payal Gupta, Pratibha Jamwal, P Swathi, Aishwarya Boddapati and Shourgrakpam Vijaya Devi.

- INSV Tarini covered over 22000 Nautical miles (Approx 40000 KMs), visiting five countries – Australia, New Zealand, Falkland Islands (UK), South Africa and Mauritius.

- During the voyage, It met all criteria of circumnavigation -

- Crossing the Equator twice, crossing all Longitudes, Three great capes (Cape Leeuwin, Cape Horn and Cape of Good Hope). The expedition was covered in six legs.

14. Indian Navy conducted *Prasthan*, a security exercise, off the coast of Mumbai.

15. Indian Navy's Marine Commando (MARCO) cadre conducted 2nd Asymmetric Warfare Training Exercise 'Ekatha 2018' at Maldives. Additionally, Indian Navy ship Sumedha is conducting a joint exclusive economic zone (EEZ) surveillance of Maldives.

16. Indian and French navies conducted third (final) phase of Varuna naval exercise 2018 in Indian Ocean region (IOR).

17. Indigenously developed Rustom-II Unmanned Aerial Vehicle (UAV) by Defence Research and Development Organisation (DRDO) will be delivered to armed forces by 2020. Rustom-II is part of Rustom line of Unmanned Aerial Vehicles (UAVs) indigenously designed and developed by DRDO that includes Rustom-I, Rustom-H and Rustom-C.

- It is a long-endurance UAV that has an 20 hours approximate flight time. Its medium-altitude prototype can fly at over 22,000 feet. It can fly at around 280 km/h.

18. Joint Indo-Bangladesh Army Trekking Expedition to Nanda Devi started from New Delhi. Nanda Devi (Uttarakhand) east base camp is located 4300m from sea level and has a very challenging trekking route. Summit is at 7816 Metres.

Economy

1. 15th Finance Commission (FCC) headed by NK Singh constituted Advisory Council to advise Commission on issue or subject related to Terms of Reference (ToR) to quell (*control*) strong opposition from some states over

2011 census. It will also help commission in broadening its ambit and understanding to seek best national and international practices on matters pertaining to fiscal devolution.

2. As major relief to budding entrepreneurs, government allowed startups to avail tax concession only if total investment including funding from angel investors does not exceed INR Rs 10 crores. Also, An angel investor picking up stakes in a startup should have minimum net worth of 2 crore or should have an average returned income of over Rs 25 lakh in preceding 3 financial years.

As per Ministry of Finance, Goods and Services Tax (GST) revenue collected in month of April 2018 was INR
 1.034 Lakh crores, consisting Integrated GST (IGST) of 50548 crores as Biggest Component (Others are Central GST, State GST and cess). April 2018 is first ever month in which GST collection surpassed 1 lakh crore mark.
 Atal Pension Yojana (APY) Scheme's subscriber crossed 1 Crore on completion of 3 years of Its launch (May 9, 2015), With current number of subscribers standing at 1.10 Crores.

- APY is a guaranteed Pension Scheme that focuses on unorganised sector workers which constitute more than 85% of workforce. Under It APY, guaranteed pension of 1000 - 5000 will be given at the age of 60 years depending on contribution by subscribers.

- The Scheme has generated around 9.10 % CAGR (Compound Annual Growth Rate) since its inception till March 2018.

5. BSE Ltd (earlier known as Bombay Stock Exchange) became first Indian exchange to be designated as Designated Offshore Securities Market (DOSM) by US Securities and Exchange Commission (US-SEC). It will allow sale of securities to US investors through trading venue of BSE without registration of such securities with US SEC. It will ease trades by US investors in India and also enhance attractiveness of Indian Depository Receipts (IDRs) amongst US investors.

6. Bank Of Baroda signed agreement with CDSL Commodity Repository (CCRL), for pledge finance under repository ecosystem for accredited warehouses. It will boost confidence among bankers and other stakeholders like depositors and warehouse service providers. BOB becomes first public sector bank to become the repository participant.

7. Bank deposits growth fell to a five-decade low in FY 2017-18, with other savings methods such as mutual funds and insurance reduced banking competitiveness. A total deposit of 114 lakh crore was reported in the last fiscal, with growth rate of 6.7% (lowest since 1963).

8. CBDT notified A Protocol to amend existing Double Taxation Avoidance Agreement (DTAA) between India and Kuwait, for avoidance of double taxation and for prevention of fiscal evasion with respect to taxes on income.

9. Central Board of Direct Taxes (CBDT) released all 7 e-filling forms for taxpayers, For e-filling of the taxpayers for assessment year 2018-19. New ITR forms require the salaried taxpayers to break down their salary and for businessmen to provide their GST number and turnover.

- ITR-1 is called 'Sahaj' and is for the salaried person earning upto Rs. 50 lakh. 3 crore taxpayers used this file for previous year.

- ITR-2 is for the individuals and 'HUF' (Hindu Undivided Families) having income from profits and gains in business including NRIs.

- ITR-3and ITR-4 can be filled by HUFs having income under head business and profession. An individual of 80 years and above or any HUF or whose income is Rs. 5 lakh and less can file for returns in ITR-1 and ITR-4.

10. Central Statistics Office (CSO) of Ministry of Statistics and Programme Implementation released estimates of Gross Domestic Product (GDP) for 4th quarter (January-March) Q4 of 2017-18 for FY 2017-18 -

- GDP (at 2011-12 prices) in fourth quarter (Q4) registered growth rate of 7.7 %, compared to 5.6, 6.3 and 7.0 % respectively in first three quarters of 2017-18. Good Growth in agriculture, manufacturing and construction sectors (11.5%) contributed to overall growth.

- GDP at constant (2011-12) prices for 2017-18 is estimated at 130.11 lakh crores, showing growth rate of 6.7 % over 2016-17.

- At sectoral level, growth rate of GVA at constant (2011-12) prices in Q4 for agriculture & allied sectors, industry and services sectors are estimated at 4.5 %, 8.8 %, and 7.7 %.

- Per capita income (at 2011-12 prices) during 2017-18 is estimated to eb INR 86668, compared to INR 82229 for 2016-17 (growth of 5.4 %).

- GDP at current prices for 2017-18 is estimated at 167.73 lakh crores, growth rate of 10.0 % over 2016-17.

11. Child rights organisation NGO Child Rights and You (CRY) received a USD 100,000 grant from global technology major Oracle for a digitally enhanced monitoring system that would potentially improve lives of underprivileged children across 19 states.

12. Delhi based Sudeva Football Club accquired Spanish league's third division club C.D Olimpic Xativa, to expand its operations in Europe. Sudeva becomes First Indian football club to do so.

13. Department of Telecommunications (DoT) approved Bharti Airtel's acquisition of Norway based Telenor India. Bharti Airtel will buy Telenor India in a no-cash deal and will take over its outstanding spectrum payments of Rs 1650 crores.

14. Employees Provident Fund Organization (EPFO)'s approved 8.55% interest on PF for 2017-18, lowest since 2012-13. It provided 8.5% in 2016-17, 8.8% in 2015-16 and 8.75% in 2013-14 & 2014-15. This will be applied to all 120 offices of EPFO and all 5 crore subscribers.

- EPFO also decided to cut Administrative Charges by 15 Basis Points to .5% (from .65%), enabling over 5 lakh employers to save about Rs. 900 crore annually.

15. FIH Mobile, subsidiary of Foxconn Technology Group (leading global contract manufacturing giant), written off an additional \$40 million of its \$200 million inveestment in online marketplace Snapdeal.

16. Facebook will launch Whatsapp Pay, a payment service for its whatsapp platform. It will be partnering with HDFC , AXIS, ICICI and SBI banks.

17. Financial Firm Paytm acquired Chennai-based online ticketing platform *TicketNew*, owned by Orbgen Technologies, for approx. \$40 million.

18. Financial services platform MobiKwik launched Unified Payments Interface (UPI) on its platform via its own Virtual payment address (VPA) handle @ikwik.

19. Fino Payments Bank launched severral digital products, in addition to mobile banking app BPay launched in 2017. New initiatives include Unified Payments Interface (UPI), net banking, easy digi savings account and FasTag for making digital payments at toll plazas.

20. GST Council approved simplified return filing process, Including measures like -

- One monthly Return.

- Unidirectional Flow of invoices - Seller needs to upload unidirectional flow of invoices anytime during month. This would be valid document to avail input tax credit by buyer.

- Simple Return design and easy IT interface.

- No automatic reversal of credit - There will not be any automatic reversal of input tax credit from buyer's side on non-payment of tax by seller.

Due process for recovery and reversal will be carried out through a due process of issuing notice and order.
Transition - There will be a three stage transition in the new system.

- Stage I will be the present system of filing of return GSTR 3B and GSTR 1. GSTR 2 and GSTR 3 shall continue to remain suspended.

- In stage 2, new return will have facility to upload invoice-wise data and also for claiming input tax credit on self declaration basis.

- Content of return and implementation - Return will be simplified by reducing amount of information required to be filled.

- GST Council also approved to make GST Network (GSTN) a government body, with Govt. acquiring 51% stake, up from 49 % Currently.

21. Government raised customs duty on wheat from 20 % to 30 %, to curb cheaper imports and protect domestic growers. Import duty on walnut shell has also been increased from 30 % to 100 %.

22. Government reconstituted Financial Stability and Development Council (FSDC) to include secretaries from revenue department AND Ministry of Information Technology (MeitY) and Chairman of Insolvency and Bankruptcy Board of India (Currently M S Sahoo). It will make FSDC more broad-based to incorporate changes in economic regulatory framework.

23. Government's Bank Note Paper Mill India (BNPM) received environment clearance (EC) from Environment Ministry to increase production of bank note paper from 12,000 tonnes per annum (TPA) to 16,000 TPA at its Mysuru unit in Karnataka.

24. HDFC bank launched Digital Loans against Mutual Funds, in partnership with transfer agaent CAMS. It aims to reach out to customers in tier 2 and 3 markets and bring them into the digital lending fold and reducing time for availability of loan through mutual funds. Ticket size of the loans will range from Rs 1 lakh to Rs 1 crore at an interest rate of 10.5 -11%.

25. ICICI bank launched its innovation lab for digital business, headed by Rohan Angrish. It aims to create technology from scratch and help better digital business. The innovation fund for this project with partnered concerns is INR 100 crores.

26. IIM-Ahmedabad's Centre for Innovation, Incubation and Entrepreneurship (CIIE) launched *Bharat Inclusion Initiative* to build knowledge and foster innovation and entrepreneurial activity across areas such as financial inclusion, livelihood, education and health. It will aim at channelizing \$25 million over 3-4 years.

27. Income Tax Department launched ITR-2, the third income return form for assessment year 2018-19. - ITR-2 is for individuals, Hindu Undivided families (HUFs) and NRIs who have income from any sources except income from profits and gains of business or profession.

- Now, total 3 Income Tax Returns (ITRs) have now been activated by Income Tax Department - ITR-1 (Sahaj), ITR-4 and ITR-2.

- ITR-1 is primarily for salaried class of taxpayers with income up to Rs 50 lakh from salary while ITR-4 is for professionals and self-employed individuals who have opted for the presumptive income scheme.

28. India signed \$500 million loan agreement with World Bank to provide additional financing for Pradhan Mantri Gram Sadak Yojana (PMGSY) Rural Roads Project. Govt. will build 7,000 km of climate resilient roads, out of which 3,500 km will be constructed using green technologies.

29. India signed a loan agreement worth \$ 200 million with World Bank for National Nutrition Mission (POSHAN Abhiyaan), to help reduce stunting in children 0-6 years of age from 38.4% to 25% by 2022. POSHAN (PM's Overarching Scheme for Holistic Nourishment) Abhiyaan was launched by PM Modi on 8th March 2018 at Jhunjhunu (Rajasthan).

30. India signed a loan agreement worth USD 21.7 Million with World Bank's IBRD (International Bank for Reconstruction and Development) for Strengthening of Public Financial Management in Rajasthan. 31. Indian GDP Growth Forecasts (May 2018) -

- According to Fitch group company BMI Research, Indian GDP Growth will be 7.3% in FY 2018-19.

- As per Harvard University (USA), India will be fastest growing economy for coming decade and will grow at 7.9% annually, ahead of China & US.

- Asian Development Bank Projected India's Growth Rate to be 7.3 % in 2018 & amp; 7.6 % in next Fiscal, higher than 6.6 % in 2017.

- International Monetary Fund (IMF)'s Asia and Pacific Regional Economic Outlook report stated that India will be fastestgrowing economy in 2018 with growth rate of 7.4%. It will rise to 7.8% in 2019. Report also said that China and India contribute 45% to global growth.

- According to UN World Economic Situation and Prospects (WESP), India's economy is projected to grow 7.6% in 2018-19.

- Confederation of Indian Industry (CII) expects India's economy to grow at 7.3-7.7 % in 2018-19.

- Moody's Investors Service report predicted India's GDP growth forecast for 2018-19 at 7.3% and 7.5% for 2019-20.

32. Indian IT Firm Infosys acqured WongDoody Holding Company, a US-based digital creative and consumer insights agency, for \$75 million.

33. Indian Oil Corporation emerged as India's most profitable state-owned company for 2nd consecutive year, with profit of INR 21346 crores in 2017-18, followed by ONGC (19945 crore). Mukesh Ambani-led Reliance Industries is most profitable company for 3rd straight year(INR 36075 crores).

34. Joint Plant Committee (Ministry of Steel) stated that India's exports of finished steel increased by 16.7% to 9.6 million tonnes in 2017-18. Additionally, Indian tea industry also reached its highest ever production of 1,325.05 million kg and export of 256.57 million kg during 2017-18.

35. Karnataka Bank will sell 8.26 % stake (from total 14 % stake) in Universal Sompo General Insurance.36. Kerala government decided to cut excise duty on fuel to effect a INR 1 per litre reduction in petrol and diesel prices, starting June 1. Kerala is first state to slash taxes on fuel after recent huge rally in prices.

37. Kerala is first south Indian state to be visited by 15th Finance Commission, headed by N K Singh. It will assess finances of Kerala and progress made in socio-economic field and other developmental factors.
38. Kotak Securities Limited launched *Free Intraday Trading*, to allow traders to do intra-day trading without paying any brokerage per trade. Intraday trading refers to buying and selling a security on same day.

39. Manila (Philippines) based Asian Development Bank approved \$375 million loan to improve irrigation in Madhya Pradesh and help increase farmer's income. Total cost is \$535.1 million and rest \$160.71 million will be given by government. Estimated time of completion is September 2025, doubling irrigated to 2 million hectares land by 2025.

40. Ministry of Commerce and Industry created Directorate General of Trade Remedies (DGTR) in Department of Commerce, by amending Allocation of Business Rules 1961.

- DGTR will be apex authority for administering trade remedial measures including anti-dumping, countervailing duties and safeguard measures. It will merge Directorate General of Anti-dumping and Allied duties (DGAD) AND Directorate General of Safeguards (DGS).

- It will provide trade defence support to our domestic industry and exporters in dealing with increasing instances of trade remedy investigations instituted against them by other countries. Creation of DGTR will result in savings of 49 posts to Government on account of merging DGAD and DGS. Thus, its establishment will be in line with Government's goal of "Minimum Government Maximum Governance.

41. Multi Commodity Exchange of India Limited (MCX) launched India's first copper options contracts, to provide physical market participants additional instrument to hedge their price risk. It has lot size of 1 tonne in three contracts expiring in June, August and November 2018.

- Copper is third-most-consumed industrial metal, after iron and aluminium. In last few years, refined copper demand has surged in sectors like electrical, electronic products and industrial machinery.

- Copper ore production in India was 3846 thousand tonnes in 2016-17 and demand for refined copper was 820 thousand tonnes in FY16.

- Options give buyer right to buy or sell an underlined at present price on a future date. They are of two types: puts (right to sell) and calls (right to buy). Options are a better hedging instrument as compared to futures for hedgers.

- Copper options contracts will be optimal tool for stakeholders to mitigate price risk in copper, giving copper industry greater flexibility to take on price risk.

42. NMDC and NLC India will invest over USD 26 million for setting up an R&D facility for developing innovative technologies in iron and steel making. Australian Securities Exchange, India's Neyveli Lignite Corporation (NLC) and NMDC will sign Master Project Agreement (MPA) with ECT to establish world's first Australian-designed Coldry and Matmor plant in Tamil Nadu.

43. National Cooperative Development Corporation (NCDC) sanctioned INR 5000 crores for Rajasthan government farm loan waiver, To help waiver loans of small and marginal farmers.

44. National Stock Echange (NSE) approved Yes Bank to be empanelled as 'Settlement Bank' for National Securities Clearing Corporation (NSCC). Yes Bank is already empanelled as a 'Clearing Bank' for BSE, NCDEX, MCX. Bank now will provide different services to members, including Settlement and Clearing, electronic fund transfer and 'anywhere' banking and free of cost fund transfer across all centres of NSE's members.
45. Paytm Payments Bank launched a program named *AshaKiran* aimed at educating rural women about financial services.

46. Punjab National Bank reported net loss of Rs 13412 crores for Q4 quarter ending March 2018, as Biggest ever quarterly loss for any bank in Indian Banking History. It has been mainly due to provisions towards bad loans, and being badly hit by Nirav Modi led scam that has cost PNB INR 14357 crores, through unauthorised letters of undertaking and domestic loans.

- India's Biggest Bank State Bank of India (SBI) also reported record losses of INR 7718 crores in January-March quarter, mainly due to higher provisions for bad loans. All public sector banks have posted huge losses for concerned period due to NPA issues.

47. RBI imposed penalty of INR 5 crores on South Indian Bank (SIB) for non-compliance with its directions on Income Recognition and Asset Classification (IRAC) norms, Know Your Customer (KYC) norms and treasury function.

48. RBI modified norms (that were set up in 2015) for setting up International Financial Services Centres (IFSC) Banking Units (IBUs) by banks in IFSCs, applicable to IBUs set up in Gujarat International Finance Tec-City (GIFT) and other IFSCs to be set up in India.

It has been mandated for parent bank to maintain at all times minimum capital of US \$ 20 million to its IBU.
 Parent bank will be also required to provide Letter of Comfort for extending financial assistance, in form of capital support to IBU.

49. RBI released final guidelines prescribing 100 % net stable funding ratio (NSFR) for banks aimed at maintaining adequate liquidity for more resilience.

- NSFR is a long-term liquidity measurement included in Basel III liquidity standards. It is amount of available stable funding (ASF) relative to amount of required stable funding (RSF).

- RBI's 100 % NSFR guideline requires banks to fund their activities with more stable sources of funding on an ongoing basis.

- RBI notified that NSFR would be applicable for Indian banks at stand-alone as well as consolidated level. For foreign banks operating as branches in India, the framework would be applicable on stand-alone basis (i.e., for Indian operations only).

50. Reliance Industries received environment clearance for expansion of its petrochemical complex at Nagothane in Raigad district of Maharashtra, at cost approx 2338 crores.

51. Reserve Bank of India (RBI) announced to buy 10000 crores INR of government bonds via open market operation (OMO), after failing to sell all debt it had offered to bidders, yielding 7.75%. Participants should submit their offers on RBI Core Banking Solution (E-Kuber) system.

52. Reserve Bank of India (RBI) has put Govt Owned Dena Bank under prompt corrective action (PCA) framework, barring Dena Bank from extending loans, due to mounting non-performing assets (NPAs) and losses. Dena Bank is 12th Govt. Owned bank to face PCA action by RBI.

53. Reserve Bank of India (RBI) instructed Pune based Rupee Co-op Bank of Pune to continue its banking services, under Restrictions that were first imposed on February 22,2103 to August 2013 and that was extended 8 times till May 2018.

54. Reserve Bank of India directed banks authorised to deal in foreign exchange (Authorised Dealer-I Banks) to share data with Directorate of Revenue Intelligence (DRI). This requires a banking company to furnish information relating to foreign exchange transactions made or received by any person to receiving authority (DRI). DRI is top investigative agency for issues related to violation of Customs Act.

55. Retirement fund body Employees' Provident Fund Organisation (EPFO) launched *View Pension Passbook* Service for pensioners on Umang App (Unified Mobile Application for New-age Governance), to allow them view their pension passbook on mobile phones.

56. SEBI issued detailed framework for Know Your Customer (KYC) documentation of foreign portfolio investors (FPIs). SEBI also stated that non-resident Indians (NRIs), overseas citizens of India (OCI) cannot be beneficial owners of FPIs, they can only obtain an FPI licence on condition that they limit their roles to investment advisors and do not invest their money.

57. Small Industries Development Bank of India (SIDBI) and Common Service Centres (CSC) Special Purpose Vehicle (SPV) signed MoU for providing financial support village level entrepreneurs (VLEs) in CSCs. SIDBI will extend financial support to VLEs of CSCs, with minimum one year of operation, under its Direct Financing Window.

- CSC SPV will approve list of VLEs, within 25 km distance of SIDBI Branch Offices. Maximum project outlay must be 3.50 lakh and term loan requirement not exceeding 2 lakh per project.

58. Supreme Court barred all high courts from listening to any plea related to a recent RBI circular titled *Prohibition on dealing in virtual currencies,* that prohibited dealings in virtual currencies (Bitcoin etc). 59. Tata Consultancy Services (TCS) became first Indian company to reach 7 lakh crores INR market capitalisation. It is followed by Reliance Industries (5.8 Lakh crores), HDFC Bank (5.2 Lakh crores), HUL (3.4 Lakh crores) and ITC (3.3 Lakh crores).

60. Tata Steel's subsidiary Bamnipal Steel Ltd (BNPL) acquired 72.65 % stake in Bhushan Steel Ltd (BSL) for Approx INR 36400 crores. It will help banks recover NPAs amounting to over 36,000s crore. Tata Steel acquired 79 crore share at Rs 2 each. It was finalised under Corporate Insolvency Resolution Process (CIRP) of Insolvency and Bankruptcy Code 2016 (IBC).

61. US retail giant Walmart accquired 77% stake in India's largest online retailer Flipkart for \$16 billion. It will be India's largest acquisition and world's biggest purchase of an ecommerce company.

- It will include \$2 billion of fresh investment, pegging value of Flipkart at \$22 billion.

- Flipkart cofounder Sachin Bansal exits with approx INR 7000 Crores Cash, while other cofounder Binny Bansal will remain on board.

62. Western Railway (WR) has launched E-catering facility on 23 major stations, to enable passengers to pick a food item from wide range of menu from wide range of restaurants and food chains.

63. World Bank's International Bank for Reconstruction and Development (IBRD) extended \$300 mn loan to EESL to scale up energy efficiency program (2 loans for \$220 million and \$80 million).

- India Aims to avoid lifetime greenhouse emissions of 170 million tonnes of CO2 and 10GW of additional generation capacity. This would be over 50 percent of the National Mission for Enhanced Energy Efficiency target of 19.6 GW.

64. YES Bank will roll out a capacity building project with farmers in Haryana and Rajasthan under its
'Livelihood and Water Security' CSR initiative, aiming at sustainable agricultural practices and digital literacy.
65. Yes Bank launched Agenda 25×25, a framework aimed at creating a synergetic startup environment for budding women entrepreneurs in India.

- Agenda 25X25 is geared towards ensuring that by 2025, at least 25% of all entrepreneurs in India are women.

International

1. North Korea extended its Clocks by 30 Minutes, to synchronize its time zone with that south Korea, which was pulled back 30 minutes 3 years ago. Its a major step towards unification among 2 Koreas looking for peace.

2. 1st Asia Power Index Australia Based Lowy Institute -

- Termed as *giant of the future,* India is ranked 4th out of 25 nations in Asia-Pacific region. As per Report, India trails behind in indicators of defence networks and economic relationships.

- A country's overall power is its weighted average across eight measures of power - economic resources, military capability, resilience, future trends, diplomatic influence, economic relationships, defence networks and cultural influence.

- USA, China And Japan are top 3. While Russia is at 5th Place.

3. 2018 A.T. Kearney Foreign Direct Investment Confidence Index (25 Nations) -

- Top 5 - USA, Canada, Germany, UK, China.

- India is ranked at 11th, down from 8th Position in China.

4. According to Clampdowns and Courage-South Asia Press Freedom Report 2017-18 by UNESCO -

- India accounted for 82 out of 97 instances of Internet shutdown among South Asia between May 2017 and April 2018.

- Pakistan witnessed 12 while Afghanistan, Bangladesh and Sri Lanka reported just 1 instance each of internet shutdown.

5. According to report *Indian Industry's Inclusive Footprint in South Africa – Doing Business, Doing Good,* released by Confederation of Indian Industry (CII) and PricewaterhouseCoopers (PwC) -

- 140 Indian companies invested approx \$4 billion in South Africa, creating nearly 18000 direct employment opportunities.

6. Aditya Puri, managing director of HDFC Bank is only Indian in Barron's top 30 global CEO list 2018, Featuring for fourth consecutive year.

7. AfrAsia Bank Global Wealth Migration Review -

- India is named 6th wealthiest country in world, with total wealth of 8,230 billion dollars.

- USA is ranked top with total wealth of 62,584 Billion dollars, followed by China with wealth of 24,803 billion dollars and Japan (19,522 billion dollars).

8. As per Grant Thornton's quarterly global business survey -

- India slipped to 6th position globally in business optimism index for first quarter of 2018.

- Top five - Austria, Finland, Indonesia, Netherlands and US.

9. As per a UN Report, Delhi will surpass Tokyo (Japan) as most populous city in world by 2028.

10. Azerbaijan inaugurated a pipeline at Sangachal Terminal, creating first direct route to transport gas from one of world's largest fields to Europe bypassing Russia. Project is worth USD 40-billion. It consists of 3 linked pipelines that will bring gas from Azerbaijani Shah Deniz 2 field across Azerbaijan, Georgia, Turkey, Greece, Albania and Adriatic Sea to southern Italy.

11. BRICS New Development Bank (NDB) will launch Americas Regional Office in Brazil, to increase operational capabilities of NDB in Brazil.

12. Bangladesh's first communication satellite Bangabandhu-1 will be launched by SpaceX's Falcon 9 rocket from Kennedy Space Center Launch Complex 39A. It will provide wide range of broadcast and communication services throughout Bangladesh. It is built by Thales Alenia Space, a Franco-Italian aerospace manufacturer. It is named after Bangladesh's *Father of the Nation - Sheikh Mujibur Rahman*.

13. Bilateral trade between India and China through Nathu La border (Sikkim) has resumed, located at 14,200 feet.

14. Britain's Royal Navy Received its first unmanned autonomous minesweeping system, capable of operating from a land or shipbased control station.

15. Carribean Nation Dominican Republic and China established diplomatic relations, amid China's growing influence. With this, Dominican Republic has broken 77-year alliance with Taiwan.

16. Central Bank of Argentina raised interest rates by 300 basis points to fight inflationary pressures. Interest rates have been raised from 27.25 to 30.25 %, to prop up its ailing currency from sliding further against US dollar.

17. China has built world's longest cross-sea bridge with length 55 KMs, connecting Hong Kong, Macau and mainland China. It took 7 years to complete, is six lanes wide and comprises of of 4 tunnels and 4 artificial islands. It has cost approx 20 Billion USD.

- World's longest bridge is also in china, known as Danyang-Kunshan Grand Bridge, with 164.7 KM Length.

- China also aims to deliver its domestically developed AG600 by 2022, world's largest amphibious aircraft. 18. China launched a hyperspectral imaging satellite 'Gaofen-5' for comprehensive observation of

atmosphere, including air pollution. It is first China-developed satellite that can monitor air pollution.

19. China launched a new communication satellite named *APSTAR-6C*. It will offer TV transmission, communication, Internet and multimedia services to customers in Asia-Pacific region.

20. China's first domestically manufactured aircraft carrier known only as "Type 001A" started sea trials. Its name is speculated to be *Shandong*, after province of same name. It is approx 315 metres long, with displacement capacity of about 55,000 tonnes (70,000 loaded).

21. Chinese e-Commerce giant Alibaba accquired Pakistan's Largest e-commerce firm *Daraz.pk* for \$150 Million.

22. Chinese space startup *OneSpace* launched its OS-X rocket, with a 30 feet long satellite named *Chongqing Liangjiang star*. It is first private Chinese farm to launch a commercial rocket.

23. Colombia Became first South American Nation to Join North Atlantic Treaty Organization as global partner. NATO reached partnership agreement with Colombia in May 2017, just after Colombia signed peace agreement with communist Revolutionary Armed Forces of Colombia (FARC), ending longest civil conflict in Latin America.

24. Cyclonic Storm Sagar, the strongest tropical cyclone to ever make landfall in Somalia (East Africa), and first named cyclone of 2018 North Indian Ocean cyclone season. It traversed entire Gulf of Aden, affected Yemen and made landfall over northwestern Somalia.

25. Democratic Republic of Congo declared a new outbreak of Ebola in northwestern part, as 9th outbreak of Ebola since its discovery in 1976.

26. European Union's General Data Protection Regulation (GDPR) brought into full effect, clarifying individual rights to personal data collected by companies for targeted advertising and other purposes.

- GDPR sets new rules for how companies manage and share personal data. Though rules apply only to citizens of European Union, global nature of internet means that nearly every online service will be affected.

- GDPR sets a higher than ever bar for obtaining personal data on the internet, higher seen before. Rules will also force companies that suffer data breaches to disclose them within 72 hours.

27. Facebook CEO Mark Zuckerberg's Chan Zuckerberg Initiative and Bill Gates' Bill & Melinda Gates Foundation partnered to accelerate breakthroughs in education. It will focus on math, writing, and skills that correspond with things like memory and selfcontrol.

28. Finnish Comunication Giant Nokia acquired California (USA) based Internet of Things (IoT) start up *SpaceTime Insight*.

29. Forbes' World's Most Powerful People 2018 List (75 People) -

- Xi Jinping (China's President) is at top for first time ever.

- Top 5 - Chinese President XI Jinping (1), Russian President Vladimir Putin (2), US President Donald Trump (3), German Chancellor Angela Merkel (4), Amazon CEO Jeff Bezos (5).

- 2 Indians named in list - PM Modi (9th) and Reliance Chairman Mukesh Ambani (32nd).

30. Global Flight Pricing Report by Melbourne-based Rome2rio Low-cost carriers IndiGo & Air India among top 5 cheapest airlinesin world in providing international connectivity, ranked 2nd and 5th position. Air Asia X is named as cheapest airline in world.

31. Global Military Expenditure Report 2017 by Stockholm International Peace Research Institute (SIPRI) -

- India surpassed France to become 5th largest military spender.

-Top five (Amount in Billion USD) - US (610), China (228), Saudi Arabia (69.4), Russia (66.3) and India (63.9). 32. Global Urban Air Pollution database released by World Health Organisation (WHO) -

-14 Indian cities named in list of world's 20 most polluted cities in terms of particulate matter PM2.5 levels in 2016. These cities include Delhi, Varanasi, Kanpur, Faridabad, Gaya, Patna, Agra, Muzaffarpur, Srinagar, Gurgaon, Jaipur, Patiala and Jodhpur.

33. Google launched Android Things (codenamed Brillo), a variant of Android operating system for Internet of Things (IoT) devices, aiming to enable IoT machines developers to be built faster, cheaper and more secure. - *Android Things* is aimed to be used with low-power and memory constrained Internet of Things (IoT) devices, which are usually built from different microcontroller unit (MCU) platforms.

34. Guatemala (Central America) and Paraguay (South America) moved their Israeli Embassy to Jerusalem, after USA recently moved its Embassy from Tel Aviv to Jerusalem.

35. Healthcare Access and Quality Index Data for 195 countries from Global Burden of Disease Study 2016 by Lancet -

- India ranked 145th.

- Top five - Iceland (1), Norway (2), Netherlands (3), Luxembourg (4), Finland and Australia (5th rank each)

- Countries with lowest scores are Central African Republic (195), Somalia (194), Guinea-Bissau (193), Chad (192), and Afghanistan (191).

- China (48th), Sri Lanka (71st), Bangladesh (133rd), Nepal (149th), Pakistan (154th).

36. IFFCO (Indian Farmers Fertiliser Cooperative) and Indian Potash Ltd (IPL) acquired 37 % stake in JPMC (Jordan Phosphate Mines Company), Jordan's largest mining and chemical firm, for INR 900 crores.
37. IMD World Competitiveness Rankings (63 countries) -

- India rose one place to 44th. China is ranked 13th.

- Top 5 - US (1), Hong Kong (2), Singapore (3), Netherlands (4), Switzerland (5).

38. IT firm Cognizant acquired Hedera Consulting, a Belgium-based business advisory and data analytics services company.

39. India and Sri Lanka agreed on cooperation on exchange of information and other aspects to tackle smuggling of drugs in both countries.

40. India dragged USA to World Trade Organisation's (WTO) Dispute Settlement Mechanism over imposition of import duties on steel and aluminium.

- In March 2018, USA imposed heavy import tariffs on imported steel and aluminium items, sparking fears of global trade war. USA levied 25% tariff on steel and 10% tariff on aluminium imported from all countries except Canada and Mexico.

41. India named 3rd largest solar market in world in 2017 behind China and USA, in a Mercom Communications report. India had set up record 9.6 GW of solar installations in 2017, more than double 4.3 GW installed in 2016.

42. India released grant of Nepalese Rupees (NRs) 18.07 crore for river training and construction of embankments along Lalbakeya, Bagmati and Kamla rivers in Nepal. India also released 33.10 Crore rupees to Nepal towards cost of two road packages of Birgunj- Thori Road being implemented under Postal Highway Projects.

43. India sent Bangladesh its second relief consignment under Operation Insaniyat, on board INS Airavat, to help displaced Rohingya Muslims who fled Myanmar into Bangladesh following military crackdown in violence-hit Rakhine state.

44. India, Netherlands and Sweden launched first-of-its-kind joint research programme on HIV/AIDS, aimed at harnessing complementary research strengths and diverse expertise of 3 nations to catalyze development of better tools to address epidemic of HIV.

45. India's Bharat Heavy Electricals Ltd (BHEL) bagged order for executing largest hydro power project in Nepal, The 900 Megawatt Arun-3 hydro project placed by SJVN Arun-3 Power Development Company (SAPDC). Order is worth INR 536 Crores.

46. India's National Association of Software and Services Companies (NASSCOM) established 2nd Digital Collaborative Opportunities Plaza (SIDCOP) platform in Guiyang (China), as India's second IT corridor in China (1st in Dalian) to provide Indian IT firms access to Chinese software market.

47. Industrial and Commercial Bank of China (ICBC) launched China's first India-dedicated publicly offered investment fund, named *Industrial and Commercial Bank Credit Suisse India* Market Fund with over \$3.6 trillion in assets (largest in world).

- It will invest in exchange-traded funds listed on more than 20 exchanges in Europe and US that are based on Indian market. It will invest in future of Indian economy and track distribution of industrial structure across Indian market.

- This fund opens way for Chinese investors and provided good tool for low-threshold investment in India. It is also regarded as significant to boost investments in India.

48. Ireland People voted to end *abortion ban*, hailed as *a quiet revolution* in a very socially conservative country. Government proposed that law should be changed to allow unrestricted access to abortions up to 12 weeks of pregnancy.

49. Israel withdrawn its bid for a non-permanent seat at UN Security Council (UNSC) for 2019-2020 term. - UNSC has 5 permanent and 10 non-permanent members who are elected for a two-year term.

50. Japan Based Conglomerate Sony Corporation acquired London Based EMI Music Publishing, in a USD 1.9 billion deal. EMI is second-largest music publishing company by revenue. It will add over 2.1 million songs to Sony's huge list, which already owns 2.3 million copyrights.

51. Kuwait presented draft UN Security Council (UNSC) resolution, proposing to set up an international protection mission for Palestinians, after recent killing of palestinians amid their anti Israel protests at Gaza Strip.

52. Malaysia Government announced abolishing Goods and Services Tax (GST) by reducing it to 0%. New Prime Minister Mahathir Mohamad had promised to abolish 6% GST levy before his electoral victory.

53. Microsoft surpassed Google's parent company Alphabet in market capitalisation for first time in 3 years, becoming 3rd most valuable firm (at \$753 billion) after Apple (\$924 billion) and Amazon (\$783 billion).

54. National Aeronautics and Space Administration (NASA) signed an agreement with Cab Aggregator Uber to explore Urban Air Mobility (UAM) for future air transportation such as flying cars in populated areas. UAM is a safe system for air vehicles, to move passengers and cargo within a city.

55. Pakistan hosted its first ever Shanghai Cooperation Organisation-Regional Anti-Terrorist Structure (SCO RATS) legal experts meeting in Islamabad.

56. Pakistan's Parliament passed a bill granting fundamental rights to transgenders and outlawing discrimination against them.

57. Palestine submitted instrument of accession to Chemical Weapons Convention to European Union (EU), world's chemical weapons watchdog.

58. Qatar banned products from United Arab Emirates (UAE), Saudi Arabia, Bahrain and Egypt; To protect safety of consumers by stopping trafficking of goods. These 4 nations has cut all diplomatic relations with Qatar amid suspected terror financing by Qatar.

59. Researchers from Institute of Archaeology of Chinese Academy of Social Sciences and Peking University announced that Chinese civilization was born 5800 years ago and got matured 3800 years ago., after 15 years of state-funded work. First civilisation emerged in areas around Yellow, Yangtze and Western Liao rivers. 60. Russia launched world's First floating nuclear power unit into Baltic Sea, with 70-megawatt Capacity, named Akademik Lomonosov.

61. Scotland become first country to introduce a minimum unit pricing for alcohol. Alcoholic products in Scotland will cost a minimum of 50 pence per unit.

62. Swedish Academy, That organizes Nobel Prize in Literature announced that, Nobel Prize in literature will not be awarded this year due to sex-abuse allegations and other issues. Swedish Academy has been in stress due to #MeToo campaign since November 2017. Academy has been alleged of sexual misconduct by husband of one of its members.

63. UK-based data analytics company Cambridge Analytica announced to shut down its operations, after being caught in a massive data-harvesting scandal took away all of its customers. Approx 2 months ago, it was revealed that CA had illegally harvested data of over 87 million Facebook users and used it to manipulate voter behavior in 2016 US Presidential elections.

64. UN Secretary-General Antonio Guterres announced to hold a climate summit in September 2019 in New York to review commitments of 2015 Paris Agreement on Climate Change, Considering effects of climate spreading all over the world. Earlier, Guterres appointed Michael Bloomberg as his Special Envoy for Climate Action. 65. US President Donald Trump signed an executive order to create a *faith-based* initiative, which would recognize vital role of faith in American life. It would ensure that faith-based organizations have equal access to government funding and equal right to exercise their beliefs.

66. US state California's economy surpassed UK to become world's fifth largest, With GDP of \$2.7 trillion, with UK and India as Next. California is only behind USA, China, Japan and Germany.

67. USA Govt. cancelled NASA's Carbon Monitoring System (CMS) programme, amid budget constraints and higher priorities within science budget. NASA's CMS Programme costing \$10 million per year was meant to track carbon and methane, key greenhouse gases that contribute to global warming.

68. USA and Philippine Armies held their Joint annual military exercise *Balikatan*.

69. USA based software Firm Adobe acquired Magento for USD 1.68 billion. Magento works in B2B and B2C context and will help Adobe to compete with salesforce and provide functionality in e-commerce space. 70. USA pulled out of an international nuclear deal with Iran signed in 2015 by USA and 5 other Powers (UK, Russia, France, China, Germany and European Union).

- This could raise risk of conflict in Middle East, upset America's European allies and bring uncertainty to global oil supplies.

- The deal eased sanctions on Iran in exchange for the country limiting its nuclear programme, seen by many as a way to prevent Iran from obtaining a nuclear bomb.

- USA Prez Trump complained that the agreement, does not address Iran's ballistic missile programme, its nuclear activities and nor its role in conflicts in Yemen and Syria. It did not prevent Iran from cheating and continuing to pursue nuclear weapons, so it needs to be vanished and Tough Economic Sanctions are being put back on Iran.

71. USA renamed its oldest and largest stragically important military command US Pacific Command (PACOM) to Indo-Pacific Command (INDOPACOM). It is responsible for all US military activity in greater Pacific region. It has about 375,000 civilian and military personnel assigned, which also includes India. Renamed INDOPACOM will now extend its reach from Pacific Ocean to Indian Ocean Region.

72. USA withdrawn invitation to Chinese navy to participate in 2018 Rim of Pacific (RIMPAC) maritime exercise, amid China's continued illegal militarisation of islands in disputed South China Sea. RIMPAC 2019 is 26th edition of this exercise. RIMPAC is world's largest international maritime warfare exercise, held biennially near Honolulu, Hawaii (USA).

73. USA's Stanford University will assist Uttar Pradesh Government to combat chronic disease like Japanese Encephalitis (JE) and Acute Encephalitis Syndrome (AES).

74. United Arab Emirates (UAE) adopted a new system of entry visas, under which it will issue long-term residency visas for up to 10 years to international investors and 'exceptional talents' including professionals and students. It will attract investors and increase economic competitiveness globally. UAE also allowed foreign investors to own 100% of UAE-based businesses by end of 2018, up from 49% cap currently.

75. United Kingdom's National Crime Agency (NCA) listed Pakistan among top three sources for money laundering, other two being Nigeria and Russia. UK is prime destination for foreign corrupt and politically exposed people (PEPs) to launder money.

76. World Bank (WB) agreed to provide a grant to Bangladesh for meeting the basic needs of around one million Rohingyas who fled their homeland Myanmar.

77. World Health Organisation (WHO) published its first *Essential Diagnostics List*, a catalogue of tests needed to diagnose most common diseases along with number of global priority diseases.

- It aims to address inability to access diagnostic services, keeping the away from correct treatment.

- The list contains 113 tests, out of which 58 are for detection of a wide range of common conditions and Remaining 55 tests are for detection of *priority* diseases such as tuberculosis, malaria, HIV, hepatitis B and C, syphilis and human papillomavirus.

- WHO will update list on regular basis and will also issue call for applications to add categories to next edition.

- It will provide a uniform tool useful to all countries, to test and treat health complications better and use health funds more efficiently by concentrating on truly essential tests.

78. World Health Organization (WHO) launched comprehensive plan to eliminate industrially-produced artificial trans fats from global food supply by 2023. WHO calls on governments to use 'REPLACE' action package to eliminate industrially-produced trans-fatty acids from food supply. World Health Organization (WHO) also held an emergency meeting to discuss on outbreak of Ebola in Congo (Central Africa).

79. World Health Organization (WHO) validated Nepal for having eliminated trachoma, a contagious bacterial infection of eye. It makes Nepal first country in WHO's South-East Asia Region to defeat trachoma, world's leading infectious cause of blindness.

80. Yahoo launched a group messaging app called *Squirrel*, focussed on friends, family and work groups.

Meetings

1. 2018 World Robot Conference (WRC) will be held in Beijing (China) in August 2018. It will see over 12,000 competing teams and 50,000 participants from over 10 countries.

2. 2nd meeting of SCO-Afghanistan Contact Group Meeting held in Beijing . With Indian Delegation headed by Additional Secretary (Multilateral Diplomacy) Gitesh Sharma.

3. 3rd United Nations Peacekeeping Course for African Partners (UNPCAP) held in New Delhi, conducted by Centre for United Nations Peacekeeping in India (CUNPK) in partnership with USA.

4. 4th Edition of Global Exhibition on Services held in Mumbai.

- In India, services sector contributes 61 % in gross value added. India's global services exports stood at 3.4 % in 2016, aimed to be 4.2 % by 2022.

- Champion Services Sectors scheme was also launched on the occasion. 12 identified sectors where Government wants to give focused attention for promoting their development includes *Information Technology & Information Technology enabled*

Services (IT& ITeS), Tourism and Hospitality Services, Medical Value Travel, Transport and Logistics Services, Accounting and Finance Services, Audio Visual Services, Legal Services, Communication Services, Construction and Related Engineering Services, Environmental Services, Financial Services and Education Services.

- Fund of Rs. 5000 crores has been proposed to be established to support initiatives for sectoral Action Plans of Champion Sectors.

5. 57-member Organization of Islamic Cooperation (OIC) held an emergency summit in Istanbul (Turkey), to discuss recent Israeli violence against Palestinian protesters in Gaza Strip.

6. First Global Wind Summit will be held in Hamburg (Germany) in September 2018, with participation of over 100 countries. Summit will combine 2 main conferences - WindEnergy Hamburg and WindEurope, Holinsky.
- India has 33GW installed capacity of wind energy, ranking 4th after China, US and Germany. Government targets 60 GW of wind energy by 2022.

7. India hosted 15th Asia Media Summit (AMS-2018) in New Delhi, organised by Asia-Pacific Institute for Broadcasting Development (AIBD) with theme *Telling our Stories- Asia and More*.

- Established in 1977, Asia-Pacific Institute for Broadcasting Development (AIBD) is a regional intergovernmental organisation servicing countries of United Nations Economic and Social Commission for Asia and the Pacific (UN-ESCAP) in field of electronic media. It is hosted in Kualampur (Malaysia).

National

1. To make adventure sports safer, Minister of State for Tourism (IC) K. J. Alphons launched Government's newly formed Guidelines on Adventure Tourism, formulated along with Adventure Tour Operators Association of India (ATOAI). Guidelines have been framed for 15 Land Based, 7 Air Based and 7 Water Based activities which cover entire portfolio of Adventure Tourism available in India.

2. 15th Pravasi Bharatiya Divas will be held in Varanasi (Uttar Pradesh) in January 2019, with Mauritius PM - Pravind Jugnauth as Chief Guest. Theme of 15th PBD will be *Role of Indian Diaspora in building a New India*. Pravasi Bharatiya Divas is celebrated in India on 9 January, commemorating return of M K Gandhi from South Africa in Bombay on January 9, 1915.

3. 71 ministries and departments of central government have allotted INR 16500 crores for implementation of Swachh Bharat Mission (SBM) in 2018-19, as per Swachhata Action Plan (SAP) 2018-19 released recently. 4. A Web portal (www.praapti.in) and an App namely PRAAPTI (Payment Ratification And Analysis in Power procurement for bringing Transparency in Invoicing of generators), has been launched by Govt. It is meant to bring transparency in power purchase transactions between Generators and Discoms. It will capture Invoicing and payment data for various long term PPAs from Generators. It will also help make transactions in the power Sector more transparent.

5. A recent Nipah Virus (NiV) infection has been reportedy in Kerala, with Its traces were found in samples of two persons who died of viral fever in Kozhikode region, and confirmed by National Institute of Virology Pune.

- Fruit bats of Pteropodidae Family, Pteropus genus are natural host of this virus. Its first outbreak took place in Kampung Sungai Nipah, Malaysia in 1998.

- Virus is beleved to spread through direct contact with infected bats, or contaminated Fruits. Human to Human transmission from other NiV-infected people is also reported.

- Symptoms Include breathing trouble, inflammation in brain, fever, headache, drowsiness, disorientation and delirium. It can be deadly too.

6. ASEAN India Film Festival held in New Delhi, organised by Ministry of External Affairs as part of series of events to commemorate 25 years of ASEAN and India relations. Its tagline was 'Friendship through Films'.
7. According to Ministry of New and Renewable Energy (MNRE), India's installed renewable energy capacity has risen to 70 Gigawatts (GW) and 38 GW is under implementation. Thus, India is well on way to target of 175 GW renewable energy (100GW Solar, 60 GW Wind, 10 GW Biomass and 5 GW Hydro) by 2022.

8. Airports Authority of India (AAI) announced construction Goa's 2nd Airport (after first at Dabolim) at Mopa, with Both Passenger and Cargo Hub Facilities. It will become functional in 2020, with annual capacity of 30 million passengers.

9. An MoU has been signed between Government of Bihar and NTPC Limited, aiming to improve performance of Power Sector in Bihar through transfer of Barauni Thermal Power Station (720 MW) and Bihar State Power Generation Company's (BSPGCL) equities in Kanti Bijlee Utpadan Nigam & Nabinagar Power Generating Company to NTPC. It will result in better performance of these units.

10. Andhra Pradesh Govt. launched official 'NCBN' (Nara Chandrababu Naidu) App in Collector's conference in Amaravati, Aimed at implementing effective governance in Andhra Pradesh.

11. Arunachal CM Pema Khandu inaugurated State's biggest solar power plant in Itanagar, with capacity of 1 MW and cost accumulated is INR 8.50 crores.

12. Arunachal Pradesh CM Pema Khandu launched LED Solar Street Lighting System in 4 Districts (*Tirap, Longding, Namsai and Tawang*), with assistance from Rural Infrastructure Development Fund of National Bank for Agriculture and Rural Development (NABARD).

13. As a landmark reform in field of Higher Education, University Grants Commission has approved UGC (Online Courses) Regulations 2018, allowing Higher Educational Institutions to offer Programmes in completely online mode.

- It is appliaeble for disciplines in which institute has already been offering same or similar Courses at graduation level in regular mode or in Open and Distance Learning mode and from which at least one batch has been graduated and approved by statutory councils.

- Online Programmes requiring Practical/ Laboratory Courses as a curricular requirement shall not be permitted.

- Online learning shall have minimum four quadrants - video lectures, e- content, self-assessment and discussion forum to clarify doubts.

- Higher Educational Institutions will be eligible to offer Online Programmes if they have been in existence for at least five years and are accredited by National Assessment and Accreditation Council (NAAC) with a valid minimum score of 3.26 on a 4-point scale. It should also be in top-100 in overall category in the National Institutional Ranking Framework (NIRF) for at least 2 years in the previous 3 years.

- Analytics of Learning Management System shall be used for ensuring the learner's participation at least for 2 hours every fortnight.

- This initiative is a big step towards attaining the targeted GER (Gross enrolment ratio) of 30% by 2020. 14. Bharat Petroleum Corporation Limited is setting up a LPG bottling plant in Balangir district in Odisha, capable of producing 42 lakh cylinders per year and will be operational from March 2020.

15. Bhopal Smart City Development Corporation Ltd. (BSCDCL) launched India's first cloud-based Common Integrated Data Centre, Disaster Recovery Centre and Integrated Control and Command Centre (ICCC), powered by Hewlett Packard (HP). It will enable Madhya Pradesh State administration to administer multiple city civic utilities and citizen services across seven smart cities in state through central cloud.

- 7 smart cities in state include Bhopal, Gwalior, Jabalpur, Indore, Ujjain, Satna, and Sagar.

16. Bhubaneswar (Odisha) became 4th National data centre of National Informatics Centre (NIC) after Delhi, Hyderabad and Pune. New cloud-enabled National Data Centre has ability to support 35000 virtual servers. NIC hosts nearly 10,000 websites of Government.

17. Bihar CM Nitish Kumar flagged off *Krishi Mahabhiyan-cum-Beej Vikas Vahan Rath,* to create awareness among farmers about government schemes during Kharif season (2 Raths for each district). One is 'Kharif

Mahabhiyan-cum-Mahotsav Rath' that would travel to villages AND other is 'Beej (Seed)Vahan Vikas Rath' which would have Kharif seeds and pesticides for treatment of kharif crop.

18. Bihar Cabinet approved setting up of a Fisheries College at Kishanganj at a cost of Rs 40.31 crore. It also approved creation of 88 new posts in Transplant and Nephrology departments of Patna Medical College and Hospital (PMCH) for starting kidney transplant facility.

19. Bihar Govt. Requested Centre for granting Special Category Status for state, statin that It will act as catalyst for private investment and will boost employment generation.

- Concept of SCS was introduced in 1969 by 5th Finance Commission (Chaired by Mahavir Tyagi), for status was that were disadvantaged in contrast to others, because of their inherent features and low resource base. It is discretion of central govt. to give special favours to states.

- Special Category States have special socio-economic, geographical problems, high cost of production with less availability of useful resources and hence low economic base for livelihood activities.

- National Development Council accorded Special Category Status to 11 states - 7 North-East States (Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland and Tripura), Sikkim, Jammu & Kashmir, Himachal Pradesh and Uttarakhand.

20. Cabinet Approvals (May 01, 2018) -

- General Approvals -

- Approved doubling investment limit from INR 7.5 lakhs to 15 lakhs and extending time limits for subscription from May 4, 2018 to Mar 31, 2020 under Pradhan MantriVayaVandanYojana (PMVVY). It will enable upto Rs.10000 Pension per month for Senior Citizens.

- PMVVY is implemented through Life Insurance Corporation of India (LIC) to provide social security during old age and protect elderly persons aged over 60 years. It provides assured pension based on a guaranteed rate of return of 8% per annum for 10 years.

- Approved construction of 100 bedded General Hospital at Rural Health Training Centre (RHTC) Najafgarh in New Delhi at cost INR 95 Crores.

- Approved Restructuring of Indian Bureau of Mines (IBM) by abolition of certain posts of Joint Secretary-level and above, with cadre strength Unchanged.

- Approved Cadre review and formation of Group 'A' service of technical cadre of Petroleum & Safety Organization (PESO) in name *Indian Petroleum & Explosives Safety Service (IPESS)*, to enhance capacity of organization.

- Approved promulgation of Ordinance to amend a law for speedy disposal of commercial disputes, aimed at improving India's ranking in World Bank's ease of doing business index. It will bring down specified value of commercial dispute to INR 3 lakh from 1 crore. It also aims to bring down time taken from present 1,445 days in resolution of commercial disputes of lesser value.

Cabinet Committee on Economic Affairs (CCEA) Approvals -

- Approved upgradation of infrastructure at Chennai, Guwahati and Lucknow airports at a total cost of INR 5,082 crores. Chennai airport would get max INR 2,467 crores, while Guwahati and Lucknow airports would get INR 1,383 and 1,232 crores.

- Approved to provide financial assistance @ of Rs. 5.50 per quintal (INR 55 per Ton) of cane crushed in sugar season 2017-18 to sugar mills to offset cost of cane, in order to help sugar mills to clear cane dues of farmers, which have accumulated upto 19000 Crores INR

- Approved Umbrella Scheme *Green Revolution – Krishonnati Yojana* for period 2017-18 to 2019-20 with Central Share of INR 33270 crores. It comprises of 11 Schemes.

- Mission for Integrated Development of Horticulture (MIDH) - Central share of INR 7533.04 crores, MIDH aims to promote holistic growth of horticulture sector.

- National Food Security Mission (NFSM), including National Mission on Oil Seeds and Oil Palm (NMOOP) Central share of INR 6893.38 crores. It aims to increase production of rice, wheat, pulses, coarse cereals and commercial crops, through area expansion and productivity enhancement.

- National Mission for Sustainable Agriculture (NMSA) - Central share of Rs.3980.82 crore. It aims at promoting sustainable agriculture practices best suitable to specific agro-ecology.

- Submission on Agriculture Extension (SMAE) - Ccentral share of 2961.26 crores. SMAE aims to strengthen ongoing extension mechanism of State Governments, local bodies etc., achieving food and nutritional security and socio-economic empowerment of farmers.

- Sub-Mission on Seeds and Planting Material (SMSP) - Ccentral share of 920.6 crores. SMSP aims to increase production of certified seed, upgrade quality of farm saved seeds, strengthen seed multiplication chain and promote new technologies and methodologies in seed production.

- Sub-Mission on Agricultural Mechanisation (SMAM) - Central share of 3250 crores. SMAM aims to increase reach of farm mechanization to small and marginal farmers and to regions where availability of farm power is low.

- Sub Mission on Plant Protection and Plan Quarantine (SMPPQ) - Central share of 1022.67 crores. SMPPQ aims to minimize loss to quality and yield of agricultural crops from ravages of insect pests, diseases, weeds, nematodes, rodents, etc.

- Integrated Scheme on Agriculture Census, Economics and Statistics (ISACES) - Central share of 730.58 crores. It aims to undertake agriculture census, study of cost of cultivation of principal crops, undertake research studies on agro-economic problems.

- Integrated Scheme on Agricultural Cooperation (ISAC) - Central share of 1902.636 crores. It aims to provide financial assistance for improving economic conditions of cooperatives, remove regional imbalances and to speed up - cooperative development in agricultural marketing.

- Integrated Scheme on Agricultural Marketing (ISAM) - Central share of 3863.93 crores. ISAM aims to develop agricultural marketing infrastructure, promote innovative and latest technologies and competitive alternatives in agriculture marketing.

- National e-Governance Plan (NeGP-A) - Central share of 211.06 crores. It aims to bring farmer centricity & service orientation to programmes, to enhance reach & impact of extension services and improve access of farmers to information & services.

- These sub schemes/missions were approved independently as separate scheme/mission. In 2017-18, it was decided to club all these under one umbrella scheme known as *Green Revolution - Krishonnati Yojana*.

- Approved Continuation of Pradhan Mantri Swasthya Suraksha Yojana(PMSSY) beyond 12th Five Year Plan to 2019-20, with financial outlay of INR 14832 crores. Under this, new AIIMS are established and Government medical colleges are upgraded. It will lead to employment generation for nearly 3000 people in various faculty & non-faculty posts in each of AIIMS.

- Under this extension, 20 new All India Institute of Medical Sciences (AIIMS) will be established and 73 medical colleges will be upgraded.

- Approved renaming and restructuring of Multi-sectoral Development Programme (MsDP) as Pradhan Mantri Jan Vikas Karyakram (PMJVK), alomg with continuation during remaining period of 14th Finance Commission (Till 2020).

- PMJVK would provide better socio economic infrastructure facilities to minority communities, particularly in education, health & skill development.

- Criteria for identification of Minority Concentration Towns have been rationalized by lowering population % criteria of Minority Communities (50 % to 25%) and fulfilment of parameters as Given -

- Earlier Towns which were backward in terms of both in Basic Amenities and Socio-economic parameters were taken as MCTs. Now, Towns which were found backward in either or both of criteria have been taken up as MCT.

- Area to be covered under PMJVK would be 57% more as compared to MsDP. MsDP covered 196 districts, while PMJVK will cover 308 districts.

- Expenditure for continuation of programme as PMJVK will be INR 3972 crores.

- It aims to address development deficits in identified minority concentration areas. Inclusion of Minority Concentration District HQs with Minority Concentration Towns having population over 25000, Minority Concentration Blocks and Cluster of Villages as per Census, 2011 data, will extend coverage.

- PMJVK would cover 5 more States/UTs - Himachal Pradesh, Tamil Nadu, Nagaland, Goa and Pondicherry.

- Minority Concentration Areas of 61 districts out of 115 Aspirational districts have been covered under PMJVK.

- Area covered under PMJVK will have 109 MCD Hqrs., 870 MCBs and 321 MCTs.

- MOUs and Foreign Approvals -

- Approved Mutual Recognition Agreement between Institute of Chartered Accountants of India (ICAI) and South African Institute of Chartered Accountants (SAICA).

- Approved to accede to Protocol under World Health Organization (WHO) Framework Convention on tobacco control to eliminate illicit trade in tobacco products.

Estimated cost is Rs. 179.54 crore in first three years. NIMHR will provide rehabilitation services to persons with mental illnesses. It will have 9 Departments and will conduct 12 courses in area of mental health rehabilitation.

- Approved strengthening of mechanism for resolution of commercial disputes of Central Public Sector Enterprises (CPSEs) -

- New 2 tier mechanism will be put in place of existing Permanent Machinery of Arbitration (PMA) mechanism to resolve commercial disputes (excluding disputes concerning Railways, Income Tax, Custom & Excise Departments).

- At First level, commercial disputes will be referred to a Committee comprising of Secretaries of administrative Ministries / Departments to which disputing CPSEs / Parties belong and Secretary in Deptt. Of Legal Affairs. Max time at 1st Level is 3 Months.

- If unresolved at 1st Tier, dispute will be referred to Cabinet Secretary, whose decision will be final.

- Approved National Policy on Biofuels 2018, to promote biofuels, that are more environmetn friendly and match up well with ongoing initiatives of Government like Make in India, Skill Development and Swachh Bharat Abhiyan.

- Basic Biofuels - First Generation (1G) bioethanol and biodiesel.

- Expected Benefits Of Policy -

- Reduce Import Dependency.

- Cleaner Environment - will reduce CO2 emissions and Green House Gas emissions.

- Health benefits - Using cooking oil as a potential feedstock for biodiesel will prevent diversion of used cooking oil in the food industry.

- Municipal Solid Waste (MSW) Management - One ton of such waste has potential to provide around 20% of drop in fuels.

- Infrastructural Investment in Rural Areas - Addition of 2G bio refineries across country will spur infrastructural investment in rural areas.

- Committee of creditors voting rights of resolution plans will be limited to 66 % from earlier threshold of 75 %, to speed up the resolution process.

- Visakhapatnam Port Trust (VPT) - 250.89 crores of Penal Interest to be waived, although VPT will pay outstanding Principal of INR 44.69 crores. Visakhapatnam Port Trust (VPT) availed INR 110.41 crore of Ioan during 1970-71 to 1984-85. VPT could not pay interest during 1979-80 to 1989-90 due to revenue losses, accumulating huge amount of Penal Interest.

 Paradip Port Trust (PPT) - 1076.59 crores of Penal Interest to be waived, although PPT will pay outstanding Principal of INR 387.74 crores. Paradip Port Trust (PPT) availed INR 642.69 crore of loan during 1967 to 2002.
 PPT could not pay start repayment on time due to revenue losses, accumulating huge amount of Penal Interest.

23. Chhattisgarh CM Raman Singh launched Vikas Yatra from Dantewada district aimed at spreading awareness about the development the state has witnessed during curret Govt's tenure. It will include distributing free pesticides to 5.5 lakh labourers and giving smartphones to 50 lakh families under Sanchar Kranti Yojna.

24. Chhattisgarh will become first state to recruit transgenders in police force, To promote gender equality. 25. Chhattisgarh will soon get specialised anti-Naxal combat force called Black Panther, like Greyhounds unit of Telangana and Andhra Pradesh. It Raised in 1989, Greyhounds is elite commando force force that specialises in anti-insurgency operations against Naxals and Maoists.

26. Commission for Scientific and Technical Terminology adopted word '*AYUSH*' in Hindi and English languages for scientific and technical purposes. AYUSH is acronym for five traditional systems of medicine - *Ayurveda*, *Yoga & Naturopathy, Unani, Siddha and Homoeopathy*.

27. Dalmia Bharat Group adopted Gandikota Fort in Andhra Pradesh and Red Fort in Delhi, under government's 'Adopt A Heritage' scheme, for a period of five years.

28. Department of Agriculture released 3rd Advance Estimates of production of major crops for 2017-18. At 279.51 million tonnes, Record Foodgrains generation is expected in 2017-18.

29. Department of Industrial Policy and Promotion(DIPP) launched a competitive ranking framework system called *State Startup Ranking Framework 2018*, to grow a sense of competition in providing startup environment in different states(including 30 states/ UTs). These states and UTs will be evaluated based on 38

parameters categorized into 7 areas and on a score of 100 they will be ranked.

30. Department of Industrial and Management Engineering of Indian Institute of Technology (IIT) Kanpur has set up India's first Centre for Energy Regulation (CER) with help of United Kingdom Govt. It aims at providing independent advisory on matters related to power and energy sector.

- IIT-Kanpur also signed a 15-crore MoU with VTOL Aviation India to develop vertical takeoff and landing (VTOL) craft prototypes, potentially to be used as flying taxis.

31. Department of Telecommunications (DoT) released draft of new Telecom policy – *National Digital Communications Policy2018*.

- It Calls for Universal broadband coverage, creating 40 lakh jobs in digital communications sector, enhancing contribution of digital communications sector to 8% of India's GDP from 6% in 2017. These objectives are to be achieved by 2022. It also aims to hike India's rank in ITU's ICT development index to top 50, from 134 in 2017.

- Improvement in regulatory framework - The policy recognises its importance for attracting investments and ensuring fair competition, to serve needs of people.

- Rationalising spectrum regulatory regime - It recognises spectrum as key natural resource for public benefit to achieve socioeconomic goals. It calls for simplifying process of obtaining permissions from various agencies, to promote efficiency.

National Broadband Mission - It will be established to secure universal broadband access for implementation of broadband initiatives, to be funded through Universal Services Obligation Fund (USOF) and Public Private Partnerships (PPPs). Its components include- BharatNet (10 to 10 Gbps to Gram Panchayats), GramNet (connecting key rural areas with 10 to 100 Mbps), NagarNet (establish one- million public Wi-Fi Hotspots in urban areas), JanWiFi (establishing two-million Wi-Fi Hotspots in rural areas) and Fibre First Initiative.
 Satellite Communication Technologies - Government would develop an ecosystem for satellite communications in India.

- USOF's scope and modalities will be reviewed by redesigning USOF and broadening its objectives to enable universal broadband access and strengthening institutional capacity.

- Better Quality of services.

- Comprehensive data protection regime has been mandated for digital communications that safeguards the privacy, autonomy and choice of individuals.

32. Election Commission of India will aunch mobile application called *Model Code of Conduct Violation Reporting App,* ahead of 2019 Lok Sabha polls, to empower people to share evidence of malpractices directly with ECI. It will allow instant sharing of photos, audio and video clips related to electoral malpractices.
33. FMCG Firm Patanjali tied up Bharat Sanchar Nigam Ltd (BSNL) to launch Swadeshi Samriddhi SIM cards.

- It can be recharged for INR 144, for which users will get unlimited calls throughout country, 2 GB data and 100 SMS daily.

- After Roll Out, customers will get 10% discount on Patanjali products. SIM card also comes with medical insurance and life insurance covers. Medical insurance cover is for Rs 2.5 lakh, while life insurance costs Rs 5 lakh (in event of road accident).

- Patanjali also launched a new swadeshi messaging application called 'Kimbho' to compete with WhatsApp, with tagline *Ab Bharat Bolega*.

34. First International Children's Film Festival of Kerala s held in Thiruvananthapuram. Chairman of organising committee is Mukesh.

35. First Post Office Passport Seva Kendra (POPSK) run by an all-woman team began its operations in Phagwara (Punjab). It was 192nd POPSK in country and first one to be operated by an all-woman team.
36. Four States and 1 UT (*Himachal Pradesh, Haryana, Jammu & Kashmir, Uttarakhand and Chandigarh (UT)*) signed first MoU with Government's National Health Mission, for implementing Ayushman Bharat-Pradhan Mantri Rashtriya Swasthya Suraksha Mission (PMRSSM).

- MOUs were signed during Ayushman Bharat Northern Region's first workshop on PMRSSM at Shimla (Himachal Pradesh).

- Ayushman Bharat is Centrally Sponsored health insurance scheme of Ministry of Health and Family Welfare (MoHFW).

- It will target over 10 crore families belonging to poor and vulnerable population based on Socio Economic and Caste Census 2011 (SECC) database.

- It will provide Rs. 5 lakh insurance cover per family per year.

- Under it, government will set up 1.5 lakh wellness centres across the country by 2022 that will leverage on comprehensive primary health care for preventive, promotive and curative care.

37. General Conferences (May 1 - 10, 2018) -

- Ministry of Finance organized 4th Regional Conference on Futuristic, Resilient and Digital Infrastructure in Bengaluru. This Conference is a lead-up to the 3rd Annual Meeting of Asian Infrastructure Investment Bank (AIIB) to be hosted by India in June 2018.

- Women and Child Development Ministry held National Conferenceof 244 Districts under BetiBachaoBetiPadhao (BBBP) in New Delhi.

- First meeting of National Committee for Commemoration of 150th Birth Anniversary of Mahatma Gandhi at Rashtrapati in New Delhi. Committee has total of 125 members, chaired by President Ram Nath Kovind.

- Home Secretary Rajiv Gauba launched online Event Clearance System (https://conference.mha.gov.in) for grant of security clearance to conference/seminar/workshop organized in India.

- 15th Finance Commission held its First Conference on Agriculture sector, In New Delhi.

- 15th Finance Commission of India was formed in November 2017 under Nand Kishore Singh and will be operational between 2020 - 2025. Appointments Committee appointed Ashok Lahiri as Full Time Member in 15th Finance Commission, subject to condition that he steps down as non-executive chairman of Bandhan Bank. - Currently, 14th Finance Comission is Operational (2015–2020) with former Reserve Bank of India governor Y.V. Reddy.

- India and USA held 2rd round of India-US Maritime Security Dialogue in Goa, focussing on cooperation in Indo-Pacific region.

- National Workshop on Data Requirements for Disaster Risk Reduction Database Held in New Delhi, by National Disaster Management Authority (NDMA).

- India will organize a cultural festival in Egypt to commemorate 157th birth anniversary of Nobel laureate Rabindranath Tagore. An exhibition on paintings of Tagore titled 'Rabindranath Tagore: Rhythm in Colours' will be held in Giza.

- Vibrant North East 2018, an event to make people aware of government's schemes was held in Guwahati (Assam).

- Government held Kisan Kalyan Karyashala at block level all over India, under Gram Swaraj Abhiyan initiative. At the workshops, farmers from each block interacted with agriculture scientists regarding increase of farmers' income using new technologies. On this Occasion, Skill India also organized an Ajeevika and Kaushal Vikas Mela in Bhubaneswar (Odisha).

- First Apex Conference for CEOs of Smart Cities held in in Bhopal (MP). During this, Aence Française de Développement (AFD's) programme to fund Smart City projects was launched. Under this, Euro 100 million will be provided to 30- 80 selected projects (selected through a challenge) and Euro 6 million will be available for technical support.

- 29th International Maritime Boundary Line (IMBL) meeting between India and Sri Lanka held onboard INS *Sumithra* at Boundary Line off Kankesanthurai.

- Department of Empowerment of Persons with Disabilities (Ministry of Social Justice and Empowerment) organised a 'Cochlear Implant Awareness Programme' in Faridabad (Haryana).

- Exhibition called *India and the World: A History in Nine Stories* held at National Museum auditorium in New Delhi.

- 19th TOONZ Animation Masters Summit held in Thiruvananthapuram (Kerala), organised by Toonz Media Group.

- Bi-annual Naval Commander's Conference held in New Delhi.

- *Star Khel Mahakumbh* held in Dharamshala (Himachal Pradesh), seeking participation from youth across 5000 villages and 800 panchayats in various sports.

38. General Conferences (May 11 - 20, 2018)

- 6th US-India Aviation Summit held in Mumbai, jointly organised by Ministry of Civil Aviation and US Trade and Development Agency (USTDA). During this, Airports Authority of India (AAI) signed a Rs 945-crores 15 year deal with Harris Corporation of USA for development of its futuristic telecommunications infrastructure (FTI) programme.

- Customs and Department of India Posts held a first-ever Joint Conference in Vigyan Bhavan in New Delhi, to deliberate on streamlining of imports and exports by post.

- 2 day North east Regional Conference on *Physical and Social Infrastructure for Regional Development* held in Guwahati (Assam).

- Stakeholder Meeting on Samarth (*Scheme for Capacity Building in Textile Sector under Skill India Mission*) held in New Delhi. This scheme was Launched in December 2017 and aims to provide placement oriented National Skills Qualifications Framework (NSQF), by training 10 lakh persons (9 lakh in organised and 1 lakh in traditional sector) by 2020, with outlay of 1300 crores.

- First International Rail Coach Expo (IRCE) held in Chennai (Tamil Nadu), to focus on Rail Coaches and train sets, hosted by Integral Coach Factory (ICF) under Railways Ministry.

- National Conference of Fisheries Ministers of Coastal states held in New Delhi.

- NITI Aayog and Vision India Foundation organized Venture Capital Symposium 2018 to deepen economic relationships between France and India. 20 big French venture capital participated in event, to explore investment opportunities.

39. General Conferences (May 21 - 31, 2018) -

- A children's theatre and personality development workshop held in North Delhi, organized by Indira Gandhi National Centre for Arts (IGNCA).

- Workshop on Challenges and Opportunities of Arbitration in SAARC region held in New Delhi.

- Minister of State for Social Justice and Empowerment Krishan Pal Gurjar committed to provide govt financial assistance worth Rs 6 Lakh for cochlear implant of children with hearing impairment in economically weak sections of Sikkim.

- Tribal Affairs Minister Jual Oram launched an exhibition cum sale event, *the PANKHA (Hand-fans)*, created by TRIFED through its artisans from all over the country at its showroom Tribes India in New Delhi.

- Railways conducted a one day workshop "Mission Raftaar" aimed at raising average speed of freight trains and coaching trains in New Delhi. Mission Raftar aims at doubling average speed of freight trains and increasing average speed of coaching trains by 25 kmph over 5 years.

- India and Pakistan held meeting of their coast guard officials in New Delhi.

- Actor Akshay Kumar launched twin pit toilet technology campaign in New Delhi, to spread awareness on issue and make cleanliness drive more effective.

Smart Cities India 2018 Expo held in New Delhi, with a vision to help develop attractive and safe cities.
 34th meeting of Central Sanctioning and Monitoring held in New Delhi. During it, Construction of new 1.5 lakh affordable houses (most in Andhra Pradesh was approved, under Pradhan Mantri Awas Yojna (Urban). It has an investment of 7227 crores with central assistance of 2209 crores. It took number of houses under PMAY(U) to 47,52,751 houses.

- 1st biannual IAF Commander's conference held at Air headquarters in New Delhi.

40. Google's philanthropic arm Google.org announced \$3 million in grants for teacher training and educational content creation in India.

- Google will also facilitate all Gram Panchayats in Andhra Pradesh with internet access, by installing 25000 Wi-Fi hotspots by December 2018.

41. Government appointed Uttam Pacharne as regular Chairman of Lalit Kala Akademi.

42. Government approved setting up an exclusive *Brahmaputra Study Centre* at Gauhati University (Assam), with funds approx INR

28 crores. It will offer an opportunity for research in different aspects of river Brahmaputra in physics, hydrology, waterways, environment, disaster/flood management, hydro-power production etc.

43. Government will link additional 200 wholesale mandis to online trading platform eNAM (electronic National Agriculture Market) in 2018-19 and will encourage inter-mandi transactions. At present, 585 regulated mandis in 14 states are linked with the

- eNAM, with 73.50 lakh farmers, 53,163 commission agents and over 1 lakh traders registered on it. eNAM is pan-India electronic trading portal for farm produce which aims creates unified national market for agricultural commodities by integrating existing Agriculture Produce Market Committee (APMC) markets.

- It provides single window service for all APMC related services, including commodity arrivals and prices, provision for responding to trade offers, buy and sell trade offers, among other services.

44. Government's Film Facilitation Office will launch dedicated web portal for disseminating information on filming locations and facilities available in India for production. It will help potential production companies looking to shoot in India to obtain permissions and explore potential benefits.

45. Government's Unnat Jyoti by Affordable LEDs for All (UJALA) scheme (implemented by Energy Efficiency Services Ltd) has so far distributed over 30 crore light emitting diode (LED) bulbs across country.

- It has led to energy savings worth INR 15581 crores, increased penetration of LED in domestic market to 10% from mere 0.4% earlier.

- It has increased India's share in global LED market to 12% from a mere 0.1%.

46. Gujarat government signed an MoU with Poland government, regarding centenary celebrations to mark independence of Poland in Delhi and other regions of world.

47. Gujarat government unveiled its *Reuse of Treated Waste Water Policy,* that aims to reduce state's dependence on freshwater sources like Narmada river. It will promote use of treated wastewater and will see setting up of sewage treatment plants (STP) across Gujarat.

48. Gujarat government will launch free treatment scheme for road accident victims, by bearing medical expenses of up to 50,000 rupees for each victim of a road accident in for first 48 hours.

49. Guwahati became India's first railway station run by solar power, with 2352 solar modules installed with a capacity of generating 700 kwp.

50. Haryana Government approved an affordable housing policy *Housing for all-2018* for core areas of municipalities in state. Town and Country Planning Department would be delegating power to Urban Local Bodies Department for implementation. Key Highlights -

- For core areas, projects would be allowed in core areas of municipal towns with an area 1 - 5 acres, while floor area ratio (FAR) should be 250 and for 2.5 to 5 acres, it should be 275.

- Allotment rate is 4000 per sq ft in hyper potential zones, Rs 3,000 per sq ft in high potential zones, Rs 2,500 for medium potential zones and Rs 2,100 per sq ft in low potential zones.

- Beneficiaries would be provided financial assistance of Rs 2.5 lakh.

51. Haryana Govt. will launch *Chatra Parivahan Suraksha Yojana*, developed for safety of girl students in Haryana.

52. Himachal Pradesh Food, civil supplies and Consumer Affairs department launched an app for ration card holders, called ePDS (electronic public distribution system). Beneficiaries can use digital ration card in ration shops. HP government also recently started Himachal Grihni Suvidha Yojna, which will provide 1 lakh women with gas cylinders and stoves free of cost.

53. Himachal Pradesh Government launched *Prakritik Kheti Khushhaal Kissan Yojana,* to promote Zero Budget Natural Farming System. It would increase soil productivity, decrease use of fertilizers and harmful chemicals and increase water infiltration. State Govt. also Launched a week long *Polythene Hatao,Paryavaran Bachao* Campaign.

54. Himachal Pradesh government will spend 25 crore rupees on renovating h istoric British Raj 'Bantony Castle Estate' as a major tourist attraction. It was accquired by government for over 27 crores two years ago, from a Business family.

55. Home Ministry approved Central Assistance of INR 1161 Crores to Assam, Himachal Pradesh, Sikkim, Lakshadweep (UT) and Rajasthan -

- Assam (480 Crores), Himachal Pradesh(84 Crores), Sikkim (67 Crores) were affected by floods/ landslides during 2017-18.

- Lakshadweep (2.6 Crores) was affected by cyclone Ockhi.

- Rajasthan (526 Crores) affected by kharif drought during 2017.

56. Human Resource Development Prakash Javadekar Minister launched *Samagra Shiksha'* - an integrated Scheme for school education extending support to States from pre-school to senior secondarylevels for first time It will treat *school* holistically as a continuum from pre-school, primary, upper primary, secondary and senior secondary levels.

- It focuses on improving quality of education at all levels by integrating two T's – Teachers and Technology.

- Earlier budget on 3 education schemes (SSA, RMSA and Teacher Education) was 28,000 crores in 2017-18. But, budget outlay on new scheme will be 34,000 crore in 2018-19 and 41,000 crores in 2019-20.

- 10 Lakh schools will get library grant of 5,000 to 20,000 to strengthen libraries.

- Every school will get sports equipment under *Samagra Shiksha* - 5000 for Primary, 10,000 for Upper Primary & up to 25,000 for SSC & HSC schools.

- Kasturba Gandhi BalikaVidyalaya (KGBV) will be expanded from Class 6-8 to Class 6-12 with 4385.60 crores in 2018-19 & 4553.10 crores in 2019-20.

- *DIKSHA* - national digital platform for teachers would put high quality teaching learning resources for ready use of teachers. *Samagra Shiksha* Scheme will support 'Operation Digital Board' in all secondary schools over a period of 5 years, so as to enhance use of digital technology through smart classrooms. Digital initiatives like ShaalaKosh, Shagun, ShaalaSaarthi will be strengthened.

57. India Meteorological Department (IMD) teamed up with Bharat Sanchar Nigam Limited (BSNL) to send extreme weather alerts to people. BSNL and IMD will send area-specific alerts to users if they happen to be at place likely to experience extreme weather conditions, even if their phone numbers do not belong to that particular telecom circle.

58. India Meteorological Department (IMD) wil add 30 more doppler radars in 2 years, with 14 in northeast, 4 in Jammu and Kashmir and 3 each will be Uttarakhand and Himachal Pradesh.

- Doppler radar is an observational tool used for precisely monitoring and predicting severe weather events such as hailstorms, thunder storms, cyclones and tornados.

- It uses Doppler effect by bouncing microwave signal off desired target to produce velocity data.

- It mainly gives information about wind velocity and precipitation. Doppler radar has radius of 250 km and helps in issuing forecasts two-three hours prior to severe weather conditions.

- First Doppler radar in India was installed in Chennai, Tamil Nadu in 2002. There are currently 27 Doppler radars in country.

59. India launched 9th and biggest ever auction of City Gas Distribution (CGD) networks, offering permits to companies for selling Compressed Natural Gas (CNG) and Piped Natural Gas (PNG) in 86 geographical areas. - Companies with net worth over 150 crore can bid for cities with a population of 50 lakh and more.

Companies with 100 crore net worth can bid for cities with 20 lakh to 50 lakh population and firms with Rs 5 crore net worth can bid for cities with under 10 lakh population.

60. Indian Pharmacopoeia Commission (IPC) approved animal-free tests for drug manufacturers. It replaces pyrogen test carried out on rabbits and abnormal toxicity test carried out on guinea pigs and mice with tests that can be done in test tubes. These guidelines will come into effect from July 1, 2018.

- Pyrogen test will be replaced by bacterial endotoxin test or monocyte activation test which can be carried out in test tubes.

- It is carried out to check impurity that can cause adverse side-effects. Drug is injected into rabbit and it is closely observed for feverish symptoms.

- For abnormal toxicity test, Vaccine manufacturers can apply for waiver by getting compliance certificate from National Control Laboratory.

- This test is carried out to check hazardous biological contamination in vaccine formulations. In this, mice or guinea pigs are injected with vaccine. The scientists observe if there is death of any animal.

61. India's longest Rail and Raod bridge *Bogibeel bridge*, linking Dibrugarh in Assam to Pasighat in Arunachal Pradesh will be inaugurated in 2018. It is 4.94 km long and stays 32 metres above waters of Brahamaputra River. At present, travel from Dibrugarh to Arunachal Pradesh by train takes over 500 km detour. This bridge will bring travel length under 100 km.

62. International Labour Organization (ILO)'s *World Employment and Social Outlook Report* projected increase in surface temperature due to global warming will lead to around 2,59,000 job losses in India by 2030. Global temperature rise of 1.5°C by end of 21st century will result in heat stress, which will reduce total number of working hours by 2030.

- It will result in 5.3% rise work loss in percentage of total hours and productivity loss equivalent to 30.8 million full-time jobs.

- Agricultural workers will be worst affected, with loss of around 64% of working hours lost by 2030 due to physical nature of their work.

63. Karnataka Assembtly Election Results 2018 -

- Bharatiya Janata Party (BJP) emerged as largest party by winning 104 out of 222 Seats. INC (Indian National Congress) won 78 seats and Janata Dal (Secular) won 40 Seats.

- Votes Percentage - BJP (36.2%), INC (38 %), JDS (18.3%)

- Karnataka Election witnessed maximum expenditure by candidates and parties ever, estimated at 9500 - 10500 crores.

64. Kerala CM Pinarayi Vijayan inaugurated Samagra Resource Portal and mobile app. More than 40,000 classrooms in Kerala will be made hi-tech by June 2018, through Samagra. Samagra is designed to make sure that all learning objectives are transacted through lesson plans as specified in curriculum.

65. Kerala Government approved setting up of *Kerala Fibre Optic Network Limited*, to offer free internet to over 20 lakh poor families. A Joint Venture company will be launched by *IT Infrastructure Limited*, *State Electricity Board and state government* to get this task done.

66. Kerala Govt inaugurate world's largest bird sculpture, Jatayu Earth's Centre in Thiruvananthapuram. The Replica of Jatayu, a character in Ramayana is 200 feet long, 150 feet wide, 65 feet tall and is positioned at top of a rock at 1000 feet above sea level.

67. Kerala State Electricity Board (KSEB) signed a memorandum of understanding with the National Thermal Power Corporation (NTPC) for increasing solar power generation in state, including setting up a 15 MW solar power unit at NTPC complex in Kayamkulam.

68. MHA created a new Division to address issues of women safety comprehensively. Punya Salila Srivastava has been posted as Joint Secretary to head this Division. It will deal with - Crimes against women, SCs&STs, Crimes against children, elderly persons, Anti-trafficking Cell, Matters relating to Prison legislation and prison Reforms, Schemes under NIRBHAYA fund, Crime and Criminal Tracking & Network System (CCTNS) and National Crime Records Bureau (NCRB).

69. Madhya Pradesh CM Shivraj Singh Chouhan launched *My MP Rojgar Portal* to provide jobs to youths as per their educational qualification, skills and interest and ensure availability of able candidates to employers as per their needs, as part of *Ham ChhuLenge Asman* programme.

70. Maharashtra Government launched a new scheme to help the landless labourers from the Scheduled Castes to acquire agricultural land, paying only 5 % of cost. The rest up to 8 lakh rupees will be borne by Maharashtra government. This is a modified version of Dadasaheb Gaikwad empowerment scheme for landless labourers scheme, that offered 50 % subsidy.

71. Maharashtra Government will provide Rs 3 subsidy for every litre of milk to co-operative and private producers to manufacture milk powder, aimed at encouraging production of milk powder from surplus milk. Milk producers in Maharashtra will get Minimum Support Price (MSP) of INR 27 per litre.

72. Maharashtra State Government became first state to sign a MoU with Centre's Green Rating for Integrated Habitat Assessment (GRIHA) Council to train state's Public Works Department (PWD) officials to rate government buildings. Objective is to encourage environment friendly buildings, that are designed using environmentally responsible processes.

73. Maharashtra became first state to provide digitally-signed land record receipts (also known as 7/12 receipts), to check irregularities and bring in transparency.

74. Maharashtra government will rename Jalgaon-based North Maharashtra University after Bahinabai Chaudhari, renowned poetess of 19th century.

75. Manipur CM N.Biren Singh launched *Go to Village* mission throughout, aimed at identifying eligible beneficiaries across state and delivering government services at their doorstep. The mission has been launched in 60 villages of all 60 Assembly constituencies.

76. Manipur has become first state in the Northeast and the third state in India to have solar toilets. Solar panel that are fitted to the toilets absorb heat to generate power, also have efficiency to transform waste material.

77. Minimum Wages (Delhi) Amendment Act 2017 has been officially notified after of President's Aproval. It amends Minimum Wages Act 1948, and was passed by Delhi Assembly in August 2017.

- As per new rules, employers violating labour rules in Delhi will now face fine ranging from Rs 20000 to 50000 and jail term of one to three years.

- Courts will be required to dispose it off within a month from the date of filing.

- Delhi Government hiked minimum wages of unskilled, semi-skilled and skilled workers by 37 %. Minimum Wages are -

- Unskilled worker - 13350

- Semi-skilled - 14698

- Skilled persons is Rs 16182 in Delhi.

78. Minister of Agriculture & Farmers' Welfare Radha Mohan Singh laid foundation stone of frozen semen station in Maranga, Purnea (Bihar), being set up at a cost of Rs 64 crore under Rashtriya Gokul Mission (100% contribution from Central Government). It aims at increasing milk production through artificial insemination techniques used by CMOFED (Sudha) in Bihar.

- Rashtriya Gokul Mission was initiated in December 2014 with an aim to conserve and develop indigenous breeds.

79. Minister of Commerce and Industry Suresh Prabhu launched Intellectual Property (IP) mascot – IP Nani, at conference on National Intellectual Property Rights Policy in New Delhi.

- Mascot IP Nani is a tech-savvy grandmother who helps the government and enforcement agencies in combating IP crimes with the help of her grandson "Chhotu" aka Aditya. IP mascot will spread awareness about the importance of Intellectual Property Rights (IPRs).

- National IPR Policy is a vision document that aims to create synergies between all forms of intellectual property (IP), concerned statutes and agencies. It aims to adapt global best practices to Indian scenario. In this regard, Cell for IPR Promotion and Management (CIPAM) was created in 2016 under DIPP.

80. Ministry of Agriculture and Famers Welfare unveiled Model Agriculture Produce and Livestock Contract Farming and Services (Promotion & Facilitation) Act 2018, to ensure better price to farmers and encouraging investment from agribusiness and food processing industries.

- Under contract farming, agricultural production can be carried out based on pre-harvest agreement between buyers and producers (farmers or farmer organisations). It reduces risk of fluctuating market price and demand.

- Model Act seeks to create regulatory and policy framework for contract farming and servives. It covers contract farming in agriculture crops, livestocks, dairy and poultry products. It lays special emphasis on protecting interests of farmers, considering them as weaker of two parties entering into a contract.

- It makes mandatory for covering contracted produce under crop and livestock insurance in operation. Under it, no permanent structure can be developed on farmers' land or premises.

- It establishes Contract Farming Facilitation Group (CFFG) for promoting contract farming and services at village or panchayat at level.

81. Ministry of Civil Aviation notified Draft Passenger Charter defining rights for air passengers, aiming to improve hassle-free air travel experience of air passengers. Salient Features --

- Passenger can cancel air ticket within 24 hours of booking it and if provided travel is to take place after 96 hours, passenger will be able to cancel ticket without any charge. Cancellation charges will be not more than sum of basic fare and fuel surcharge.

- Airline must either offer alternative flight that departs within 2 hours of scheduled departure of flight booked originally or refund ticket cost. Full refund is to be issued If airline doesn't inform passengers about cancelled flight up to 24 hours ahead.

- For delays communicated more than 24 hours before scheduled departure, airline must offer option of full refund of ticket cost if delay is for more than 4 hours.

- If delay results in flight departing next day, then airline will have to offer free hotel stay. These norms will be applicable only

- if delay is due to fault of airline, and not caused by bad weather.

If delay results in a passenger missing a connecting flight, then airline will have to pay Rs.5,000 to Rs.20,000. In case of lost baggage, minimum compensation proposed is INR 3000 per kg. If baggage is delayed or damaged, airline is liable to pay Rs. 1,000 per kg.

- If passenger doesn't receive due compensation, grievances can be filed on Ministry of Civil Aviation's AirSewa app or at Directorate General of Civil Aviation (DGCA) portal.

82. Ministry of Culture organized 9th Rashtriya Sanskriti Mahotsav under *Ek Bharat Shrestha Bharat*, in Tehri (Uttarakhand), also subsuming Tehri Lake Festival (where one can explore water sports) within itself.

- Rashtriya Sanskriti Mahotsav (RSM) presents rich diversity and uniqueness of Indian culture and promotes cultural interlinkages amongst states to strengthen National integration.

- Paired state for Uttarakhand under Ek Bharat Shreshtha Bharat matrix is Karnataka, giving special emphasis to Karnataka in the event.

83. Ministry of Electronics and Information Technology (MeITY) launched Digital India Internship Scheme along with its website.

- Under this, 25 interns will be inducted for period of three months. These interns will be paid a stipend of Rs. 10, 000 per month.

- Eligibility - Indian students from recognized universities who secured over 60% marks in last held degree. Students pursuing B.E/B.Tech or M.E/M.Tech or dual degrees can apply for internships on the portal.

- Internship will be offered two times in year - summer Internship during May and June and winter Internship during December and January.

 Proposed broad areas for Internship are Cyber Security, e-Governance, Digital Literacy (HRD), International Cooperation & Industrial Promotion, Hardware Industry and Digital Payments and Electronic Testing.
 84. Ministry of Environment, Forest and Climate Change (MoEFCC) launched Green Skill Development Programme (GSDP), to train over 5.5 lakh workers in environment and forest sectors through 30 courses by 2021 for sustainable conservation of natural resources.

- GSDP-ENVIS mobile application was also launched to provide more information and applying to courses under GSDP programme.

- GSDP was launched in 2017 by MoEFCC in partnership with National Skill Development Agency (NSDA) to develop green skilled workers having technical knowledge and commitment to sustainable development. 85. Ministry of Environment, Forest and Climate Change (MoEFCC) rolled out 'Gaj Yatra', an awareness campaign to protect elephants from Tura in Garo Hills of Meghalaya. Under this, elephant mascot will be taken across districts frequented by jumbo herds for generating awareness.

86. Ministry of Human Resource Development (HRD) launched initiative for development of 1.5 million higher education faculty using massive open online course (MOOC) platform SWAYAM (Study Webs of Active Learning for Young Aspiring Minds). Under first phase, 75 discipline-specific National Resource Centres (NRCs) have been identified.

- NRCS includes varied institutions under Ministry's Pandit Madan Mohan Malaviya National Mission on Teachers and Teaching (PMMMNMTT), in Central Universities, IISc, IUCAA, IITs, IISERs, NITs, State Universities,

UGC's Human Resource Development Centres (HRDCs), National Institutes for Technical Teachers Training (NITTTRs), IIITs, Open Universities.

87. Ministry of New and Renewable Energy issued National Wind-Solar Hybrid Policy, aiming at promotion of large grid connected wind-solar PV hybrid system for efficient utilization of transmission infrastructure and land. It provides for integration of both energy sources (wind and solar) at AC and DC level.

- It also provides for flexibility in share of wind and solar components in hybrid project, subject to condition that, rated power capacity of one resource be at least 25 % of rated power capacity of other resource for it to be recognised as a hybrid project.

- Policy permits use of battery storage in hybrid project for optimising output and further reduce variability.

- With significant capacity additions in renewables, and Hybrid Policy aiming at better utilisation of resources, it is envisaged that Hybrid Policy will open-up a new area for availability of renewable power at competitive prices.

- A scheme for new hybrid projects under the policy is also expected shortly.

88. Ministry of Railways has launched new user interface of its Next Generation e-Ticketing (NGeT) System on Indian Railway's (url -www.irctc.co.in/nget).

- Using it, user can enquire trains and check availability of seats without logging in to system, saving time of users.

- It will provide enhanced class-wise, train-wise, destination-wise, departure and arrival time wise and quota wise filters for facilitating customer while planning their journeys.

- It also has waitlist prediction which will allow user to get probability of wait-listed or RAC tickets getting confirmed.

-User can find out availability for entire Advance Reservation Period (of 120 days), except for few trains in improvised page.

89. Ministry of Road Transport and Highways (MoRTH) approved green licence plates bearing numbers in white fonts for private evehicles and yellow for taxis to promote electric vehicles. It aims at easy identification of electric vehicles for preferential treatment in parking, free entry in congested zones besides other proposed benefits like concessional toll.

- India presently has approx 1 to 1.5 lakh electric vehicles. It is projected to grow to about 5% of total vehicles in next five years.

90. Ministry of Tourism expanded Buddhist tourism circuit under Swadesh Darshan Scheme to 21 more states to make it India's first trans-national tourist circuit. Earlier it was envisaged only to 7 major Buddhist pilgrimage sites in Uttar Pradesh and Bihar.

91. Ministry of Tribal Affairs (MoTA) will expand Van Dhan Vikas Kendras in tribal districts, with 3000 such kendras proposed to be set up in 2 years. Initially, it will be taken up in 39 districts with over 50% tribal population and then will be expanded to other Tribal Districts.

- Van Dhan Yojana aims at mainstreaming tribal community by promoting primary level value addition to Non Timber Minor Forest Produce (MFP) at grassroots level. It also aims to promote MFPs-centric livelihood development of tribal gatherers and artisans.

- Through this, share of tribals in value chain of Non-Timber Forest Produce is expected to rise from 20% to around 60%.

92. Ministry of Women and Child Development (WCD) approved setting up additional 100 One Stop Centres (OSCs) for women affected by violence, in Haryana, Himachal Pradesh, Madhya Pradesh, Maharashtra, Mizoram, Nagaland, Odisha, Tamil Nadu and Uttar Pradesh.

- OSC are funded from Nirbhaya Fund. Aim is to provide women with services such as police assistance, medical aid, psychosocial counselling, legal aid and counselling, temporary stay for 5 days etc.

93. Mumbai police will use Unmanned Aerial Vehicles (UAVs) for surveillance and install 'panic buttons' in order to enhance safety of women in the city, as part of INR 252 crores Safe City to be implemented in 3v years.

94. NITI Aayog and ABB India signed a Statement of Intent (SoI) to government realise its vision of 'Make in India' through advanced manufacturing technologies that incorporate latest developments in robotics and artificial intelligence. NITI Aayog will work with ABB across various sectors, to suggest solutions for digitalisation, incorporating Internet of Things (IoT) and Artificial Intelligence (AI) technologies.

95. NITI Aayog and Actor Sushant Singh Rajput collaborated to promote 2 major initiatives of NITI Aayog - promotion of BHIM and Women Entrepreneurship Platform.

96. NITI Aayog and Google signed a Statement of Intent (SOI), to work on a range of initiatives to help build AI (Artificianl Intelligence) ecosystem across country.

97. NITI Aayog and IBM signed a Statement of Intent (SoI) to develop a crop yield prediction model using Artificial Intelligence (AI) to provide real-time advisory to farmers in aspirational districts. Aim is to enable cooperation in the use of technology to provide insights to farmers to improve crop productivity, soil yield, control agricultural inputs with the overarching goal of improving farmers' incomes.

98. National Crime Records Bureau (NCRB) is creating a national registry of crimes against women, amid growing concern over incidents of sexual assaults. Records will be sourced from the Crime and Criminal Tracking Network and Systems (CCTNS).

99. National Mission for Clean Ganga (NMCG) launched *Yamuna River Front Development (RFD) project* implemented by Delhi Development Authority (DDA), named *Asita* (Another name for River Yamuna). It aims to restore, revive and rejuvenate river's floodplains and make them accessible to the people of Delhi. 100. Navratna CPSE National Aluminium Company Limited (NALCO) signed MoU with Ministry of Mines, setting highest ever target of Rs 9350 crore revenue from operations for FY 2018-19, 15% higher than last year.

- It aims at production of 2.1 million tons Alumina with 100% capacity utilisation & an optimum Aluminium production target of 4.15 lakh tonnes.

101. Nobel laureate and noted economist Muhammad Yunus (Bangladesh) has been honoured with 11th KISS Humanitarian Award 2018 in Odisha.

102. North Eastern state Arunachal Pradesh has been put on air connectivity map after its first commercial flight (of Alliance Airlines) landed at Pasighat Airport (East Siang district), under UDAN scheme. Alliance Air (subsidiary of Air India), will operate flight services on Kolkata-Guwahati-Pasighat route thrice a week.
103. Northeast Frontier Railway started operating one lease Parcel Cargo Express Train (PCET) on fortnightly basis, connecting Northeast to West Coast, Connecting New Guwahati in Assam to Kalyan in Maharashtra with stoppages at New Jalpaiguri, Kalumna Goods Shed.

- It would enable farmers in North east to market their products like tea, betal nuts, pineapple, jute, horticulture products, cane furniture etc. at the retail markets in Mumbai, Bengaluru, Nagpur, Pune etc.

- A single PCET can carry consignment equivalent to 52 trucks. This will ensure less Carbon Emission which will contribute for Green India & saving of foreign exchange on account of purchasing of fuel.

104. Oil and Natural Gas Corporation (ONGC) began its operations in Nagayalanka block in Krishna District (Andhra Pradesh). This Early production System (EPS) has cost 6804 crores.

105. PM Narendra Modi inaugurated India's first smart and green highway-135 km long Kundli-Ghaziabad Palwal (KGP) Expressway also known as Eastern Peripheral Expressway (EPE).

- It has been completed in about 500 days, as against target of 910 days with cost INR 11000 crores. PM also inaugurated first phase of Delhi-Meerut Expressway, India's first 14 lane expressway and spans from Nizamuddin Bridge to Uttar Pradesh border.

 Several Features of Expresswauy Include Solar power Plants, Rainwater harvesting, Closed tolling system, Weigh-in-Motion (WIMs) equipment, Auto Challans, Intelligent Traffic management AND Green cover.
 106. PM Narendra Modi inaugurated Kishanganga Hydroelectric Project and laid Foundation Stone of Pakal Dul Power Project in J &K -

- Kishanganga Hydroelectric Project -

- With capacity of 330 MW, This project in Bandipora District of Jammu and Kashmir is a run of river scheme, that is designed to divert water from the Kishanganga River to a power plant in Jhelum River basin.

- It has been completed at cost of INR 5882 crores. Kishangana H.E. Project will provide free power of 13 % to

J & K, of approx 133 crores per year.

- Pakal Dul -

- With 1000 MW capacity, it will be largest Hydro Power Project in J & K on completion. To be built on Marusadar River (a right bank tributary of Chenab), It is also first storage Project in state. Its sansctioned cost is INR 8112 crores.

- As it is a storage project, it shall improve water availability during lean season.

- It will employ Around 3000 persons during construction and 500 persons shall be employed during operationphase.

- J&K will get 12 % free power after 10 years of commissioning of Project.

107. PM Narendra Modi inaugurated Zojila tunnel project, to provide all-weather connectivity between Srinagar, Kargil and Leh. Its Length will be 14.2 km, making it country's longest road tunnel. It will cut down time taken to cross Zojila pass from 3.5 hours to

15 minutes. It will also be Asia's longest bi-directional tunnel and will be built at a cost of INR 6,809 crores. 108. PM Narendra Modi laid foundation stone today for 2400MW first phase of NTPC's Patratu Super Thermal Power Project in Jharkhand, as a 74: 26 Joint Venture between Government of Jharkhand (GoJ) and NTPC Owned Patratu Vidyut Utpadan Nigam Ltd. (PVUN). PVUNL will develop it in two phases: 2,400 MW (3x800MW) in Phase-I and 1,600 MW (2x800 MW) in Phase-II.

- It will allocate 85 % of power to Jharkhand. Under Pradhan Mantri Sahaj Bijli Har Ghar Yojana (Saubhagya) scheme, it will ensure 24x7 power availability to households.

- Engineering, Procurement & Construction contract of the project has been awarded to BHEL. Commissioning of first unit is envisaged in 2022.

109. Pakyong airport in Sikkim will be 100th operational airport in country, after its commissioning in June 2018. Post commissioning, Airline SpiceJet will be operating flights to Pakyong in Sikkim from Kolkata under UDAN (Ude Desh ka Aam Naagrik).

110. Patanjali Ayurved has been ranked as India's most trusted Fast Moving Consumer Goods (FMCG) brand (overall 13th) in TRA's Brand Trust Report 2018. Top Brand is Samsung and Top BFSI (Banking, Financial services and Insurance) is SBI.

111. Power Grid Corporation of India (PGCIL) signed pact with Ministry of Power to incur capital expenditure of INR 25000 crores for current fiscal.

112. President Ram Nath Kovind inaugurated Integrated Centre for Crisis Management (ICCM) at Bhabha Atomic Research Centre (BARC) Mumbai. It will help respond more effectively to chemical, biological, radiological and nuclear (CBRN) emergencies, monitoring radiological data from 504 radiation sensors across country. Other launches Include -

- Multi-leaf collimator system It enables gamma radiation to be exposed only on cancer-affected organs.
- Trombay Chhattisgarh Dubraj Mutant-1 High-yielding dwarf variety of Dubraj mutant rice.
- Metal fuel pin fabrication facility Will help increase plutonium production in fast breeder reactors.
- High-power electron beam melting furnace To be used for nuclear and strategic applications.

- Integrated enriched boron tri-fluoride gas generation facility - It was developed by Heavy-water Board in Odisha. It will be used in neutron detectors.

113. President Ram Nath Kovind launched three public welfare schemes in Rajasthan - Sundar Singh Bhandari EBC Swarozgar Yojana, Bhairon Singh Shekhawat Antyodaya Swarozgar Yojana and loan and interest waiver scheme for SCs/STs/OBCs, sanitation workers, physically challenged -

- Sundar Singh Bhandari EBC Swarozgar Yojana - Government will provide loans of up to Rs 50000 to members of economically backward classes (EBC) from around 50,000 families at 4 % interest rate.

- Bhairon Singh Shekhawat Antyodaya Swarozgar Yojana - State government would provide loans worth up to Rs 50000 at 4% interest rate to about 50,000 families from the scheduled castes and tribes and other backward classes for selfemployment.

- Loan waiver scheme - State government would provide 2 lakh worth interest-free loans to people belonging to SC/ ST community and other backward classes for skill development and create employment resources.

114. Press Council of India Chairman C.K Prasad rejected Reporters Without Borders (RWB)'s World Press Freedom Index report 2018 that was recently released and ranked India 138th among 180 Nations in terms of level of freedom for media. PCI stated that the report had *lack of clarity*.

115. Punjab CM Amarinder Singh announced several development projects worth 555 crores for up-gradation of border district of Tarn Taran.

116. Punjab Government signed MoU with United Kingdom (UK) for setting up of bio-gas and bio- Compressed natural gas (CNG) plants in state. It aims to find a sustainable solutions to paddy straw burning, which is a major concern in Punjab and surrounding region.

117. Punjab government along with WWF-India will conduct first organised census of Indus Dolphins, one of world's rarest mammals. Dolphins are found only in India and Pakistan, confined to 185 km stretch between Talwara and Harike Barrage in India's Beas River in Punjab.

118. Rajasthan Government launched *Nidaan* software, for diseases monitoring and strengthening telemedicine services in government hospitals. It will help in providing presumptive monitoring of seasonal and non-communicable diseases as well as trends of ailments found in specific areas. 119. Social network Facebook partnered with National Commission for Women (NCW) to launch Digital Literacy Programme to train women on safe use of internet and social media. Under it, awareness training will be conducted for 60,000 women in universities across major cities over 1 year.

120. Solar Energy Corporation of India (SECI) is named as Nodal Agency to set up 2.5 GW Wind-Solar hybrid Project by Ministry of New and Renewable Energy, aiming to Build Hybrid Projects with Transparent Bidding Process limited from 200 MW to 500 MW, with atleast 1 project site with capacity of 50 MW. As of now, we have only 20 GW of renewable energy produced through windsolar hybrid power projects.

- Govt aims for 175 GW Renewable energy capacity by 2022. As of now, India has over 20 GW of Solar Power And approx 354 GW of Wind power Installed Capacity.

121. Supreme Court (SC) approved *Compensation Scheme for Women Victims/Survivors of Sexual Assault/Other Crimes-2018*, as a uniform compensation scheme for victims of sexual assault and acid attacks. It was prepared by the National Legal Services Authority (NALSA). It provisions Fines ranging 2 - 10 lakhs for several kinds of crimes against women.

122. Supreme Court approved Centre's draft Cauvery Management Scheme for smooth distribution of water among Karnataka, Tamil Nadu, Kerala and Puducherry (UT). SC raised Karnataka's share of Cauvery water by 14.75 tmcft saying that issue of drinking water of Southern Karnataka region is of higher priority. Tamil Nadu's share is reduced, compensated by allowing TN to extract 10 tmcft more groundwater from river basin.

- Cauvery Management Scheme deals with release of water from Karnataka to Tamil Nadu, Kerala and Puducherry, implemented by Cauvery Management Authority (CMA).

123. Supreme Court ruled that courts can look into Parliamentary Standing Committee reports while deciding on an issue. However, parliamentary reports cannot be challenged in Courts. It will help NGOs, which frequently file PILs in theSC, to rely on Parliamentary Standing Committee reports.

124. Supreme Court struck down a legislation that allowed former Uttar Pradesh Chief Ministers to continue occupying government accommodation even after demitting office, terming it as *arbitrary and discriminatory*. 125. Swachh Survekshan 2018 Results -

- Top 3 cleanest Cities - Indore (Madhya Pradesh), Bhopal (Madhya Pradesh), Chandigarh.

- Stats -

- Organized by Ministry of Housing and Urban Affairs (MoHUA) Under Swachh Bharat Mission (Urban), It Assessed 4203 Urban Local Bodies, compared to 434 cities covered in 2017 and 73 cities in 2016.

- Record 37.66 lakh citizen feedbacks were collected during Swachh Survekshan 2018.

- In ranking cities, 35% weightage given to each of citizen feedback & service level progress, 30% weightage given to direct observation. In 2017, it was 25 % to direct observation, 30 % to citizen feedback and 45 % to service level progress.

- Cleanest cities in various categories -

- Big City - Vijaywada (Andhra Pradesh)

- Medium City - Mysuru (Karnataka)

- Small City - New Delhi Municipal Council

- State Capital / UT - Greater Mumbai (Maharashtra)

126. Tamil Nadu government demanded permanent closure of controversial Vedanta Group's Sterlite Copper factory in Thoothukudi/ Tuticorin, which was centre of violent protests recently that led to killing of 13 people in Police Firing. Locals had been protesting for closure of the factory for 100 days. The actions of police has been highly criticised.

- Protests intensified after Sterlite Copper recently applied for to double capacity of plant to 800,000 metric tonnes per annum.

- Residents of nearby villages claimed that smelter caused huge level air and water pollution and is the reason behind unnaturally high cancer rates in surrounding villages.

127. Tata Motors and Maharashtra Government signed MoU to deploy 1,000 Electric Vehicles across a range of passenger and commercial vehicles in Maharashtra. Also, Mahindra & Mahindra signed two MoUs with Maharashtra Government to advance its next phase of expansion in electric vehicles (EVs) and achieve its goal to become completely electric ready.

128. Tata Trusts signed MoU with Government to provide development support in eight worst Naxal-affected districts in Chhattisgarh, covered under Transformation of aspirational districts Programme of NITI Aayog. Districts are - Kanker, Rajnandgaon, Bijapur, Bastar, Kondagaon, Dantewada, Narayanpur and Sukma.

129. Telangana Govt. announced setting up of a new Pay Revision Commission (PRC) for government employees, giving special allowances to employees working in remote areas.

130. Telangana government completed rejuvenation of 18,000 tanks in Telangana under its Mission Kakatiya programme, as announced at a convention on 'Rejuvenation of Krishna river'.

131. Telangana government launched Rythu Bandhu (friend of farmers) Scheme, an investment support scheme to support livelihood of farmers. It is first such investment support scheme for farmers to be launched by any state in India.

- Farmers will directly get financial support twice every year to maximise agricultural production. They will get support of 8,000 per acre every year (Rs. 4000 each for monsoon and Rabi season) as crop investment support.

- State government has set aside Rs 12,000 crore in 2018-19 budget exclusively for this scheme.

- State government also announced to provide life insurance cover to all farmers in state for Rs five lakh each, from August 15, 2018 Onwards.

132. Telecom Commission approved voice and data in-flight connectivity, permitting Internet and Mobile Communication on Aircraft (MCA) in Indian airspace. It is recommended to permit MCA services with minimum height restriction of 3000 meters in airspace.

133. Telecom Regulatory Authority of India (TRAI) issued *Telecommunication Interconnection (Amendment) Regulations 2018* to amend interconnect regulations, proposing certain changes in terms and conditions for operators to seek fresh call connect ports from other operators.

- Service provider can ask another operator for additional ports or Point of Interconnection (POI), when utilisation of capacity exceeds 85% over 60 day period. Time frame for provisioning of ports for initial interconnection and augmentation is to be increased to maximum 42 working days.

134. Telecom Regulatory Authority of India (TRAI) proposed use of blockchain technology to check menace of Unsolicited Commercial Communication (UCC) or spam calls / messages. Blockchain technology based norms will record all communication between subscribers and entities, capturing customer consent for information and authorised telemarketing agencies. Subscriber will be now able to revoke consent given to entities through TRAI app and other mechanism that will be provided under regulation.

135. To enable customers to check if medicine is genuine, Govt will mandate brands to print a unique 14 character code on packages. Sending this code to a number will tell if medicine is genuine.

136. Tripura Government announced 10% of all police force will be reserved for women, to encourage women to participate and deal more efficiently with crimes related to them.

137. Tripura Horticulture Corporation Limited (THCL) signed an MoU with Spicejet Merchandise Pvt Ltd, To provide pineapples to majority of country and help farmers earn profit.

138. UNICEF (United Nations Children's Emergency Fund) launched Data Visualisation App to provide user friendly visual representation of complex analytics of education scenario in India, developed with technical inputs from UNICEF, NCERT and National Institute of Education Planning and Administration (NIEPA).

- It uses UDISE (Unified District Information System for Education), NAS (National Assessment survey) and demographic data. It can be used as visual tool by policy makers, academia and researchers to address gaps and monitor programs in education.

139. United Nations Development Programme (UNDP) will set up a skill development centre for clients of Bharosa, an integrated support centre for distressed women and children in Hyderabad (Telangana). It aims at empowering marginalised women by imparting skills training.

140. United Nations Environment Programme (UNEP) recognised Cochin International Airport Ltd (CIAL) in Kerala as world's first fully solar energy powered airport. CIAL is India's first airport to be constructed in public-private-partnership (PPP) model in 1999.

- It has 15 MWp solar power plant, comprising 46,150 solar panels laid across 45 acres. Plant generates 50,000 units of electricity daily.

141. Uttarakhand Govt inaugurated state's first (and India's 8th) City Gas Distribution (CGD) network at Rudrapur in Udham Singh Nagar district, comprising 500 km long pipeline and 10 CNG stations.

142. World's largest Indian national flag has been unfurled in Hyderabad (Telangana), which is 122 feet in length and 183 feet in width.

1. 16 year old Shivangi Pathak became India's youngest female to scale Mount Everest (Nepal).

2. According to *World Leaders on Facebook* study by Burson Cohn & Wolfe, Indian PM Narendra Modi is most 'liked' world leader on Facebook. With 4.3 Crore Followers, he is way ahead of USA President Donald Trump (2.3 Crore Followers).

3. Australian Steve Plain became fastest climber to scale highest peaks on seven continents, taking 117 days, after he scaled Mount Everest. He began his mission by climbing Mount Vinson in Antarctica. Record was earlier held by a Polish climber who scaled in 126 days.

- Indian mountaineer Arjun Vajpai become youngest person to scale six peaks over 8000 metres when he summited Kangchenjunga (Sikkim), third highest mountain in world. He intends to become youngest person in world to scale all 14 above 8000 metre-peaks. His next is Shishapangma (8013 metres) in Nyalam County, Tibet.

Also, Sangeeta Bahl became oldest Indian woman to conquer Mount Everest, at 53 years of age.
 Indian-origin lawyer Person Gobind Singh Deo become first Sikh in Malaysia to be appointed as a Cabinet minister, after being allotted communications and multimedia portfolio. Another Indian-origin lawmaker M Kulasegaran has been appointed as human resource minister.

5. Nepali woman Nima Jangmu Sherpa created world record by scaling 3 highest mountains in a single climbing season within 25 days - Kangchenjunga (8586 metres), Nima summited Lhotse (8516 metres) and Everest (8848 metres).

<u>Science</u>

IceCube, a small NASA satellite has developed first global map of ice clouds. Ice clouds start as tiny particles high in atmosphere. They absorb moisture, and become heavier. This make them to fall to lower altitudes. Ice clouds affect Earth's energy budget by absorbing Sun's energy and by affecting emission of heat from Earth into space. IceCube will operate for a year, and then it will reenter Earth's atmosphere and burn up.
 According to study by Gravity Recovery and Climate Experiment (GRACE) spacecraft mission of German Aerospace Center and NASA, India has seen sharp decline in availability of freshwater, due to overuse by humans, climate change and natural cycles.

3. American Spzce Exploration Firm SpaceX launched twin NASA satellites GRACE-FO (Follow-On) that will track Earth's water Cycle i.e. water movement and icemelt.

- GRACE-FO (Gravity Recovery and Climate Experiment Follow-On) is joint project between NASA and German Research Center for Geosciences (GFZ), as as follow-on mission to GRACE mission, which mapped Earth's water and ice by measuring changes in Earth's gravity field from 2002 to 2017.

- To measure Earth's gravity, 2 GRACE-FO satellites will orbit around Earth together, with one trailing behind other at distance of 220km.

4. An important peptide that can be used to create a new preventive vaccine against leptospirosis (tropical infectious disease) has been found by researchers from Gujarat Biotechnology Research Centre. At present there is no preventive vaccine for Leptospirosis.

- Researchers learned whole protein set of bacteria Leptospira interrogans by narrowing down to one effective immunogenic protein.

- This protein was found in almost all serovars (different types within a species) of the bacteria.

5. Andhra Pradesh Government notified its new state symbols, after bifurcation of undivided Andhra Pradesh in 2014 that led to formation of New State Telangana. New state symbols -

- State bird - Rose-ringed parakeet (Psittacula krameri). Locally known as Rama Chiluka.

- State tree - Neem (Azadirachta indica). Locally known Vepa Chettu.

- State animal - Black-buck (Antilope cervicapra). Locally known as Krishna Jinka.

- State flower - Jasmine (Jasminum officinale).

- State symbols of Telangana - Bird - Indian Roller (It also state bird of Odisha and Karnataka), Tree: Jammi Chettu, Animal - Spotted deer. Flower - Tangidi Puvvu.

6. Astronomers discovered a first of its kind carbon-rich asteroid in Kuiper Belt, designated as 2004 EW95.

- Kuiper belt is a circum-stellar disc in outer Solar System, extending from orbit of Neptune to approximately 50 astronomical unit (AU) from Sun.

- 2004 EW95 seems to have formed in the asteroid belt between Mars and Jupiter and then would have been flung billions of kms to its current locations.

7. China launched relay satellite *Queqiao (Magpie Bridge)* to establish communication with its planned Chang'e-4 lunar probe (rover) that will explore dark side of moon.

- Queqiao (meaning bridge of magpies) will serve as communications relay for future Chang'e-4 rover that will explore in South Pole-Aitken Basin in moon's far side. It will be world's first communication satellite operating

in halo orbit – Earthmoon Lagrange point L2, a gravitationally stable spot located 64,000 kilometers beyond lunar far side.

- Need for relay Satellite -

- Moon is tidally locked to Earth, it always shows same face (near side) to Earth. So, relay link is necessary to communicate with spacecraft on far side, which will otherwise have to send their signals through moon's rocky bulk.

- Under China National Space Administration (CNSA)'s Chang'e program (Chinese Lunar Exploration Program), Chang'e 1 and Chang'e 2 probes already have reached lunar orbit in 2007 and 2010 respectively. Chang'e 3 mission is in process to put lander and rover on moon's near side.

8. Genetic Engineering Appraisal Committee (GEAC) demanded more tests for genetically modified mustard-Dhara Mustard Hybrid (DMH -11) for *commercial cultivation*. It has called for 'field demonstrations' of GM mustard in an area of 5 acres at several locations, to study possible impact transgenic crop could have on honey bees.

- GEAC had given final clearance for GM mustard (in May 2017). Clearance was later put on hold by Environment Ministry.

- Even high-powered panel on Doubling Farmers' Income (DFI) said Genetic Engineering is 'powerful' tool for developing future crop, but for now it should be adopted only for non-food crops.

Dhara Mustard Hybrid (DMH -11) is transgenic mustard developed by Centre for Genetic Manipulation of Crop Plants at Delhi University. It is genetically modified variety of Herbicide Tolerant (HT) mustard.
ISRO's Liquid Propulsion Systems Centre (LPSC) is developing environment-friendly propellant propellant blend based on hydroxylammonium nitrate (HAN) to power satellites and spacecrafts, aiming to replace conventional hydrazine fuel, Which has dominated space industry as choice of propellant for over six decades despite hazards.

- HAN-based monopropellant formulation consists of HAN, ammonium nitrate, methanol and water. Monopropellant is chemical propulsion fuel which does not require separate oxidizer. It is used extensively in satellite thrusters for orbital correction and orientation control.

- HAN-based monopropellant will replace conventional hydrazine rocket fuel, a highly toxic and carcinogenic chemical, with greener propellant for future missions. It will also ensure cost effective re-usable, recoverable, re-startable and reliable space launches of ISRO.

10. Indian Institute of Science Education and Research (IISER) developed a *Arsenic Sensor and Removal Media* device to remove arsenic content from water and make it safe for use. It is capable of sensing soluble arsenic which cannot be easily removed. It is highly sensitive as it can sense up to parts per billion (ppb) levels, compared to currently available techniques that sense parts per million (ppm). Arsenic is a natural component in earth's crust, widely distributed and highly toxic in its inorganic form.

 Indian National Centre for Ocean Information Services (Ministry of Earth Sciences) has developed a new model that would predict how far sea water would travel after violating natural boundaries. It would be a Level-3 alert under India's Tsunami Early Warning System, which was put in place after 2004 tsunami. Level-1 tracks magnitude of a tsunami and Level-2 generates an alert about a potential tsunami and wave height.
 Indian Space Research Organization developed an atomic clock to be used in navigation satellites to measure clear-cut location data. Currently ISRO imports atomic clocks from European aerospace manufacturer Astrium for navigation satellites.

- It will be used on seven navigation satellites of India as part of Indian Regional Navigation Satellite System (IRNSS) or NaVIC. Currently 3 NAVIC satellites have 3 imported Rubidium atomic clocks.

13. Japanese scientists invented procedure to produce alcoholic beverages from wood of cherry, cedar, and birch trees. Fourkilogram cedar wood produced 3.8 litres of liquid, with 15% alcohol content.

14. NASA discovered a special kind of neutron star outside the Milky Way galaxy for first time. Neutron stars are highly dense cores of massive stars that collapse and go through a supernova explosion. It was spotted via NASA's Chandra X-ray Observatory and European Southern Observatory's Very Large Telescope (VLT) in Chile. 15. NASA will launch mission InSight (Interior Exploration using Seismic Investigations, Geodesy and Heat Transport) to study deep interior of Mars on May 5, 2018. Rocket will also launch two mini-spacecraft called Mars Cube One (MarCO), NASA's technology experiment. InSight is stationary lander that will be first NASA mission since Apollo moon landings to place seismometer, a device that measures quakes on soil of another planet. 16. National Aeronautics and Space Administration (NASA) demonstrated that Its Kilopower portable nuclear fission reactor could enable crewed missions to Moon, Mars and beyond.

- Kilopower Reactor Using Stirling Technology (KRUSTY) experiment was conducted by NASA at in November 2017 – March 2018, established that this system can create electricity with fission power.

- KRUSTY is a small, lightweight fission power system which is capable of providing up to 10 kilowatts of electrical power continuously for at least 10 years. This prototype uses a solid uranium-235 reactor core.
17. Researchers from Indian National Centre for Ocean Information Services (INCOIS) and US National Oceanic and Atmospheric Administration (NOAA) found that global warming is driving proliferation of Noctiluca algae (known as sea tinkle), a harmful algae in Arabian Sea responsible for glowing of Mumbai's beaches in dark.
- Noctiluca algae is parasite and occurs in patches or blooms in northern Arabian Sea. The algae compete with fish for food and choke their supply. It also excretes large amounts of ammonia, which causes massive fish mortality.

 Researchers from Northumbria University (UK) found out mountain ranges and three vast, deep subglacial valleys hidden under Antarctica ice. This is first finding observed from ice penetrating radar data collected in Antarctica as part of European Space Agency PolarGAP project. Largest valley, named Foundation Trough, is over 350 kilometres long and 35 kilometres wide. Other 2 are Patuxent Trough and Offset Rift.
 Scientists at Central Sheep and Wool Research Institute (CSWRI) Rajasthan invented a new laparascope assisted insemination technique for sheep breeding. It is minor invasive laparascopic technique involves passing rigid fibre-optic laparoscope into abdomen through small incision.

- It resolvs difficulties in freezing of semen and inability to transit tortuous reproductive tract of sheep kept as livestock. It will also help achieve up to 60% survival in birth of lambs.

20. Scientists created world's smallest house – build on an area of 300 square micrometres – using a robotic system that can accurately assemble nanomaterials into tiny, desirable structures. Researchers from Femto-ST Institute in France, assembled new microrobotics system that pushes forward frontiers of optical nanotechnologies.

- With advancement, optical fibres as thin as human hair can be inserted into inaccessible locations like jet engines and blood vessels to detect radiation levels or viral molecules.

21. Scientists discovered first interstellar immigrant, an Asteroid named (514107) 2015 BZ509 (Also called Oumuamua) that has a different origin other than our solar system because it moves in a direction opposite to that of all objects in our solar system.

22. Scientists discovered new frog species named *Microhyla kodial* or Mangaluru narrow-mouthed frog in a region in coastal Karnataka. It is seen only in small industrial region which was former timber dumping yards wurrounded by seaport, petrochemical, chemical and refinery industries. It is small in size measuring just 2 cm long.

23. Scientists discovered world's oldest lizard fossil, named Megachirella wachtleri, in Dolomites mountain range of Italy. Fossil is 240 million years old.

24. Scientists discovered world's second oldest grain of magmatic zircon (mineral that contains traces of radioactive isotopes) from Champua from Singhbhum rock sample in Odisha's Kendujhar district. It is oldest magmatic zircon on earth.

- Isotopic analysis of Singhbhum rock sample with magmatic zircon was done used Sensitive High Resolution Ion Microprobe (SHRIMP) at Chinese Academy of Geological Sciences. It confirmed presence of two zircon grains that aged 4240 million and 4030 million years.

- Oldest zircon on earth was found in Jack Hill (Western Australia), which is 4400 million years old. It is metamorphosedsedimentary rock.

25. Scientists found a drug named "PLX5622" that could prevent the brain damage caused by exposure to cosmic radiation, useful to spacewalkers as Humans travelling beyond Earth's protective magnetic fields will be exposed to cosmic radiation nearly 1000 times higher than that on Earth.

26. Scientists from Newcastle University (UK) created world's first 3D printed human corneas that could solve problem of shortage of available eye donors and help millions of blind people gain sight again.

- Cornea is outermost layer of the human eye. Its key function is to focus vision. It also barricades eyes against harmful dirt and bacteria.

- 3D printed human corneas were produced using bio-ink solution consisting of healthy corneal stem mixed together with alginate and collagen.

27. Scientists from Tohoku University in Japan found mineral called moganite in lunar (Moon's) meteorite that points presence of abundant hidden reserves of water ice under surface of moon. The mineral discovered in a desert in northwest Africa could be potentially useful for future human exploration of moon.

- Moganite is a crystal of silicon dioxide (SiO), known to form on earth in specific circumstances in sedimentary settings from alkaline fluids.

- Researchers believe that mineral formed on surface of moon in area called Procellarum Terrane as water was present in lunar dirt, that evaporated due to strong sunlight. But in subsurface, water remains in form of ice.

28. Scientists from University of Minnesota (USA) discovered that chemical element ruthenium (Ru(44)) is fourth element to have unique magnetic properties (ferromagnetism) at room temperature, after Iron (Fe), Cobalt (Co), and Nickel (Ni). The discovery will help to improve sensors, devices in computer memory and logic industry or other devices using magnetic materials. It was discovered in 1844 by Russian-born scientist Karl Ernst.

29. Scientists of Chinese Academy of Sciences discovered a 400 Million Year old fossilised body piece of an extinct class of marine animal named Cystoidea or cystoids at Guizhou province (China).

30. Tapanuli Orangutan, the rarest ape species on Earth, is on verge of extinction with only approx 800 members of the species alive. This species was discovered in 2017 in Sumatra (Indonesia).

31. Uropeltis bhupathyi, a new snake species has been discovered in the Anaikatty hills, Coimbatore, Tamil Nadu. It has been named after late herpetologist S. Bhupathy. They are non-venomous, burrowing, mostly earthworm-eating.
